

2017 DAYTON ALL*STAR QUALIFIERS RULES

FORMAT:

- ❖ The Dayton All*Star team will consist of a total of 28 men and 15 women who will be determined by qualifying scores.
- ❖ The top 24 men & 12 women are guaranteed a spot on one of the 6 Men's, or 3 Women's teams. The remaining players are alternates and will be utilized as needed. Both Men's and Women's coaches will be appointed by the DDA.
- ❖ The Dayton All*Star teams will compete against All*Stars teams from Cincinnati, Columbus & Cleveland in the Quad-City Challenge on Sunday, December 3, 2017.

ELIGIBILITY:

- Any Dayton (and surrounding area) resident may qualify. *Quad-City Rules state*, "All team members must reside within an 80-mile radius of their club/association's mailing address."
- You do not have to be a paid DDA member in order to qualify or be on the All*Star team.
- Non-DDA members are entitled to All*Star team benefits, but not full DDA membership benefits.
- > Players who are NOT in good standing with the DDA are excluded from qualifying.

BENEFITS:

- ✓ All players that make the Dayton All*Star team will receive a personalized shirt. Coaches will also receive a personalized shirt.
- ✓ The All*Star shirt must be worn during the Quad City Challenge.
- ✓ Only the top 6 men and the top 3 women will receive a \$50 bonus.
- ✓ Failure to participate (in good faith) in the Quad City Challenge will result in a forfeit of the bonus and shirt.
- ✓ As a paid DDA member, you have free entry to the annual banquet, participation in Divisional Single Events, and participation in the City Championship event. Membership dues are (\$20.00) yearly.

QUALIFYING:

- 1) Qualifying fees are \$3.00 per sheet. Fees *must be paid* before the darter begins any qualifying attempt(s).
- 2) All sheets paid for are non-refundable and non-transferable. No credit will be extended.
- 3) <u>A maximum of 3 sheets per person can be purchased at a time and thrown</u>. Additional sheets can be purchased upon the completion of the previous 3 sheets either by qualifying attempt or forfeiture/incomplete sheet (D.N.F.).
- 4) BOGO night only 3 sheets can be thrown at a time. Free sheets will be put in a separate stack; this is to give other qualifiers their time at the boards.
- 5) <u>Men</u> Each attempt consists of 3 games of <u>301 double in</u>, <u>double out</u>
- 6) Women Each attempt consists of 3 games of 301 straight in, double out
- 7) You will be shooting for the lowest number of darts to complete a total for 3 games
- 8) The qualifying score used for determining the All*Star team is the *SUM* of 3 games total for a given qualifying attempt. A game from a different score sheet may not be used to calculate the qualifying score.

- 9) Once a darters name has been call to a board, you will have a 5-minute (max) wait time to be at the board.
- 10) If a darter is not present at the board by the 5-minute (max) wait time, the qualifier sheet will be placed at the bottom of the stack.
- 11) The darter may warm up *9 darts max* (on the game board) before starting each game of a qualifying attempt. The darter must inform the scorekeeper when they are ready to begin each game <u>prior</u> to throwing the first dart of that game.
- 12) Once the first game has begun, all three games *must be completed* without a break.
- 13) All games will be chalked by DDA board members and/or All*Star Committee Members. Scores must be verified by scorekeeper before darts are pulled from the board. If there is no verification, the scorekeeper will list that round as a zero (0) score and 3 thrown darts.
- 14) Each leg of a qualifier consists of 30 (*max out*) thrown darts or <u>less</u> for a given leg. Once a leg starts, all darts thrown count in succession as the 30 (*max out*) thrown darts or less for a given leg.

- 15) The sum of all thrown darts counts as the score for a given leg.
- 16) All bounce-outs or robin-hoods are counted as darts thrown and *cannot be re-thrown*.
- 17) A "bust" on dart one or two will be scored as three darts. Dart(s) are pulled and next round begins.
- 18) If someone gives up during a qualifying attempt, that leg and therefore the entire attempt is unfinished and *may not be resumed* later. The score sheet will be marked D.N.F. for the leg and the overall qualifying score will be recorded as a D.N.F. (Did Not Finish).
- 19) **Ties** ... <u>Upon the final night of Qualifiers</u> To determine the All Star Team... <u>On all tied qualifier sheets</u> the lowest score in a leg of thrown darts out of your 3 game total will be used.

Scheduled Qualifiers:

• There are no open qualifiers. All qualifying attempts *must be taken* on one of the scheduled dates, times and locations noted on the qualifier schedule.

- Qualifiers will begin at 3:00pm on Saturdays, Sundays and at 7:00pm on scheduled week night, except
 for Fridays which begin at 6:00pm. 2pm 3pm on Saturdays and Sundays are reserved for
 board/committee members. You are <u>WELCOME</u> to be there to watch. No qualifiers will be taken except
 for the board/committee members qualifying scores.
- Signups will close at 9:00pm on Fridays, Saturdays and 6:00pm on Sundays and at 9:00pm on the weeknights.
- You must purchase all score sheets you wish to attempt to qualify before the respective deadlines. <u>No sheets are sold after the scheduled closed time</u>. *There will be no exceptions!*
- Anyone who purchased score sheets prior to the closing time may stay until they have thrown as many qualifying attempts as were paid for.
- A valid score sheet will have the darter's name, phone number, shirt size, e-mail address, and the \$3 purchase price marked paid on it by the DDA Board/All*Star Committee member running the qualifying for the night.
- There must be at least 4 DDA Board and/or All*Star Committee Members present/taking score at every qualifier. The All*Star Secretary will not be available to take score.
- If deemed necessary by volume or conditions, Board Members taking qualifiers may call any DDA Board Member/All*Star Committee Member to assist in taking qualifiers. <u>Other Non-Board/All*Star Committee Member assistance in taking qualifiers is prohibited.</u>

- 1. Standings will be updated on a regular basis and distributed to DDA sponsor locations. Additionally, standings will be posted on the DDA website. To view go to www.daytondarting.com
- 2. The All*Star Chairperson will appoint men's and/or women's coaches, will assemble teams, appoint team captains, and schedule practices. The All*Star Chairperson will possess the list of players names, contact information and shirt sizes.
- 3. All members of the 2017 Dayton All*Star team must be in the Quad City Challenge dart hall no later than 10:00am on Sunday, December 3, 2017.

BOARD MEMBER'S RESPONSIBILITIES:

- There is no need to call in the scores.
- All score sheets are to be collected at the end of each qualifier and given to the All*Star Secretary (or DDA Treasurer), who will verify the correctness of each score. The money collected must be verified to meet with the total of the score sheets sold.

- If the sold sheets and money cannot be given to the All*Star Secretary or DDA Treasurer, they can be taken to D.E.A.D. Please let the All*Secretary know if this is done.
- Absolutely, no sheets or money are to be left at any location other than D.E.A.D.
- All*Star standings will be updated weekly by the All*Star Secretary, and distributed to the DDA Secretary and the Web Master for posting.
