**CONSENT AGENDA:**

Mayor George said the property is located East of the Library, and we are waiting on the President to sign the deed. Vondol Bailey made the motion, Preston Williams seconded, five was for, the motion carried.

**ITEM #2- APPROVE RESOLUTION FROM JASPER CO. APPRAISAL DISTRICT**

Mayor George explained the new procedure, that each entity is allowed one vote. Laura Adams made the motion, Andra Grant seconded, five was for, the motion carried.

**ITEM #3- APPROVE JASPER COUNTY SEALED BID RESALE**


Mayor George said three of the properties listed are in the city limits (3,7, & 8), and that number (3) would be something that the City would want, and it would be in the best interest of the City. Mayor George said that K.C.I.S.D. has agreed to sign off, but Jasper County would have to put the issue before the Board, and pay \$1100.00, mainly for Attorney fees. Mayor George went on to say (7) and (8) are on Ivory Joe Hunter Street, and the bid is for \$625.00 each. Mayor George recommended rejecting the bid for (3), and accept the bids for (7) and (8). Preston Williams made

the motion to reject bid for (3), with the Mayor's supervision, and accept (7) and (8), Laura Adams seconded, five was for, the motion carried.


