

**TOWN OF LINCOLN
TOWN BOARD MEETING
July 11, 2022**

The meeting was called to order by Chairman Jason Headson at 6:00 pm. On a motion by Wilson, second by Black and all in favor, the agenda for the evening was approved.

The pledge of allegiance was recited.

A plaque was presented in honor of Kathy Gibbs for her service to the Town.

On a motion by Wilson, second by Black and all in favor, the consent agenda was approved including minutes of the

- Vouchers and payrolls.

Appearance by Jason Flannery. Mr. Flannery spoke on behalf of residents on Corning and Lundt Roads and Valley Lane regarding support of a petition to impose a 14-ton weight restriction on these roads. He discussed concerns with damage to these roads as well as safety and noise issues that would be brought on by long-term heavy truck traffic and the proposed gravel pit site. He also stated concerns with the effects on the ATV/snowmobile trails. Discussion ensued with various members of the public speaking of their concerns and support of weight restriction. Jason stated the Board will look into legalities of imposing weight limits, possibilities of re-routing the access road and scheduling a special meeting within the next 2 weeks to possibly enforce a weight limit on these roads. Safety concerns were also voiced over the current passing zones near Highway 8 and Corning Rd.

Plan Commission/Variance: Kyle Black reported on various projects on Park Rd., Keith Siding Rd. and the Mussons Pit application. Discussion was held on the fencing requirements for the Flannery site on County Rd. W.

Jason presented quotes for 2022 paving projects. On a motion by Wilson, second by Black and all in favor, the quotes for the 2022 paving projects were approved.

New information regarding zoning has been obtained. The Board discussed the possibilities of giving zoning enforcement to the County in order to reduce costs for the Town. Jason stated the Town would need a Resolution to opt-out, a public hearing and town electors to approve in order to do so. Lynne will research the requirements needed for the next meeting.

Prior to the meeting, Tressa informed the Board she received an application for a Class B Picnic license and an application for one operator's license. All paperwork and payments are on file. On a motion by Black, second by Wilson and all in favor, it was decided to approve the operator licenses along with the Class B picnic license.

Jason stated there are no applicants for the open Town position.

Tressa prepared the treasurer's report for the meeting, but stated to email her with any questions.
