Contestants will walk and perform according to their age group. One winner will be chosen for each Title in each age division. After each age division has had the opportunity to take the stage and present in their category there will be a short break for the judges to finish their scoring before proceeding with the pageant. Twinkle Toes Dance studio will present a few dances from this last season during some of the breaks. Winners will then be Announced, Introduced and receive awards.

What to wear and to expect:

Parent/Guardian Name:

- This is not your typical Formal Pageant this is a Natural Beauty Contest.
- Judges are looking for beauty Inside and Out. Contestants will be judged accordingly and only based on this day's events. Please dress presentable and conservatively. No Bare Bellies, Mini Skirts or plunging necklines... may result in point deductions.
- Contestants may wear pageant or party attire with limitations listed above.
- Contestants may wear make up but please no false eyelashes... try and keep as natural as possible. Babies and toddlers should look like babies and toddlers no make up please if you want a toddler to wear a dusting of lip gloss etc. it will be accepted but "stage Makeup" on the Tiny/Little Miss/Mr. could result in points deducted.
- A nonprofessional Make up free head shot, or picture will need to be submitted in hard copy or digital form before the pageant for judging in the Ideal categories. Pictures will not be returned.
- Minimal props will be allowed such as a teddy bear, sunglasses, umbrellas etc. However, throwing items may result in contestant disqualification.
- Starting this year, we will have a portion of the pageant that involves "talent/personality" demonstrations. Tiny Miss/Mr. will only take the stage and have their picture for their judging. Little Miss/Mr. age 3-5 will Freeze Dance have their Picture and Stage debut for their scoring. Little Miss/Mr. age 6-9 will perform a personality dance that is quick easy and repetitive that will be taught the morning of the pageant. The Junior Miss and Miss are going to be asked to perform a talent up to 1 minute long but no longer. This may be a song, dance or
