Miami Park Special Assessment District-2 parcels

REPORT OF SUPERVISOR

Allan read his report.

I, Allan Overhiser, Supervisor of Casco Township, Allegan County, Michigan, do hereby report that I have prepared the attached special assessment roll for Beach Special Assessment District 2023-001 in the amount of \$570,000.00 for the entire cost to acquire and contract beach improvements to be specially assessed. Such beach improvements shall be described as follows: installing a limestone boulder revetment (with walking path), two six-inch corrugated DBL, perforated pipes across the bluff above the clay for drainage and contouring to improve angle of repose, reestablishing eroded public path, and performing other and related tasks as necessary.

We have the Beach Special Assessment Roll 2023-1

Tod & Natalie Schneiderman Assessment Amount \$285,000.00 and Debbie Weaver Dan Assessment Amount of \$285,000.00.

Dan made a motion to accept the Supervisors report. Supported by Paul. All in Favor. Motion Carried.

Park Project Status & Update:

Pay request for a progress payment on construction of the park project in the amount of \$18,366.30 with explanations of expenses included in this amount.

Paul made a motion to approve the progress payment of \$18,366.30 to Davis Landscaping & Home Improvement LLC. Supported by Dan. All votes in favor. Motion Carried.

AIA Document G701 -2017 the change order for the Preserve Project

#1 changed from a septic drain field changed from a 2-zone to a 6-zpne \$130,000.00 will be deducted from the total contract because the township is purchasing the bathroom facility themselves, and the septic drain field has changed from a 2-zone to a 6-zone.

#2 changed septic pump chamber from a 186-gallon tank to a 1,000 gallon tank.

#3 change from an in-ground drain field to an above the ground mounded drain field. The bath house is now being purchased thru the township for \$150,000.00 changes the contract amount to \$341,494.70.

Dan made a motion to approve the change order of the park project. Supported by Paul. No further discussion. All Votes in Favor. Motion Carried.

Assessor Status:

Our assessor Kyle Harris has had some health issues, and he will be out for a while. His brother and sister, who are assessors also, will be taking over the functions while Kyle is recooperating.

Granicus Renewal

Allan recommended going with Granicus again, we tried another company, and it didn't work out. Dan made a motion to renew our contract with Granicus in the amount of \$11,161.72. Paul supported. No further discussion. All votes in Favor. Motion Carried.

• Early Voting issues – Clerk's compensation.

Allan made a recommendation to the board that we have a clerk that was suddenly thrown into a lot because of the Early Voting, and it will continue. In recognition of the additional responsibilities, the hours, giving up two full weekends working here that he thinks that it is only right that we recognize this with a change in the compensation. Allan felt that this should be recognized on an individual basis. Allan recommended giving the clerk a \$2,000.00 increase for this election. Paul made a motion to approve the \$2,000.00 increase to the clerk for the extra work involved in the Early Voting. Dan supported. All Votes in favor. Motion Carried.

• Treasurer's Compensation:

Allan recommended to get the Treasurer's compensation should be brought up to \$40,000.00. He will bring this up next month with a resolution, with everyone else a cost-of-living raise, whatever that percentage is this year.
