

## **Community Arts Fund** – Instructions

The Okaloosa Arts Alliance enhances the cultural environment of its community. It promotes, coordinates and nurtures high quality arts and cultural resources that enrich the lives of residents and visitors.

With support from the State of Florida's "State of the Arts" license plate proceeds and private funding, the Okaloosa Arts Alliance is pleased to offer the Community Arts Fund Grant program. Applicants will be evaluated on how their proposed projects affect the arts in our community, how it advances the mission of OAA and how it relates to the criteria listed in this document.

Wednesday, December 15, 2014 5:00 p.m.

#### Instructions:

Please submit an <u>original plus five (5) copies</u> of the complete application package and any supporting materials; and **MAIL** to the address below, postmarked no later than 12/15/20014. Packages postmarked after that date are ineligible and will not be considered. **Please do not put the package in folders, binders or in presentation packages; staple sets only.** 

### **Eligibility Criteria:**

- **Non-profit 501(C)3** organizations sponsoring arts and cultural events and **schools** located in Okaloosa County are eligible to apply.
- OAA Grant recipients may only receive one grant per fiscal year.
- Okaloosa Arts Alliance reserves the right to award partial funding of a grant or to award less than the total funds available for any given granting period.
- Grant recipients must use the funds awarded for events occurring between January 1, 2015 and December 31, 2015.
- A report documenting the actual use of funds <u>must be submitted</u> to the Okaloosa Arts Alliance within thirty (30) days of the funded project's completion. Failure to submit a final report will result in forfeiture of award and may limit eligibility for future grant applications.
- Grant requests for funding of Public performances MUST include an educational component in order to be eligible. Please include this component in your project description.

**Award Amount**: Please note, grants are typically awarded in the \$1000 range. Actual amounts available for grants will be set annually by the OAA Board of Directors. 25% of the total will be set aside for school applications; 75% will be for eligible 501(c)3 applications.

**Award Notification**: Notification of grant award will be made by the **Grant Review and Selection Committee** by January 9, 2015.

## **Community Arts Fund** – Evaluation Criteria

### **Project/Event Criteria:**

The Okaloosa Arts Alliance considers the following criteria when evaluating the reasonable goals and feasibility of an applicant's project. The project/event should:

- 1. Develop opportunities for Okaloosa County Residents to enjoy cultural activities and provide the community with access to the arts.
- 2. Enhance the quality of cultural life in Okaloosa County for both residents and visitors.
- 3. Stimulate governmental and public awareness and appreciation of the vitality of the arts in Okaloosa County, as well as the importance of the arts to quality of life in general.
- 4. Exhibit a high level of quality, professionalism, creativity, and diversity in the arts.
- 5. Create a liaison between the arts and educational communities.
- 6. Develop opportunities for "underserved populations" in the county to participate in cultural activities.
- 7. Advance the mission of the Okaloosa Arts Alliance.

### **Ineligible Project/Event Expenses:**

Community Arts Grants awarded by the Okaloosa Arts Alliance <u>may not</u> be used to fund:

- 1. On-going operational expenses
- 2. Costs for buses or any type of transportation of students to programs
- 3. Member recruitment activities
- 4. Political campaigns
