**Our studio has an annual revue/recital for our dance students.** The recital fees are added to your account on October 1. We assume that all students will be performing unless notified by parent directly. If your student does not want to be in the recital, please submit, in writing, no later than September 20 and you will not be charged these fees. There will be no refunds for those who change their plans for recital mid year.

We value commitment and base our dance fees on a full 32-36 week season. We bill our classes one month in advance on the 15<sup>th</sup> of each month. These charges for the DUE THE 1<sup>ST</sup> OF FOLLOWING MONTH. Ex: Sept 15, billed for Nov., these fees are due Oct 1<sup>st</sup>. You are responsible for this fee regardless of absences (this includes other activities) or inclement weather cancellations. Your account will be credited for any classes cancelled based on studio difficulties. We must have a credit card on file. Cash and check payments may be placed in the payment box on front desk prior to the 30<sup>th</sup>. In the event that payment isn't made with cash/check, on the 1<sup>st</sup> of each month, we will charge that card for the balance due. Music lessons are billed and due on the first of the month for the following month. Music lessons are year round but may be placed on hold for summer if requested in advance.
