Minutes of January 15, 2018

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. The meeting was called to order with the pledge of Allegiance by Jed Lamb. Also present were Dennis Finkel, Dimitri Szynal, Carl Strekely and Sheila Lanning. Robert Holmes was absent.

Motion by Rollin with a second by Lamb to approve the minutes of the January 8, 2018 special scheduled meeting as written. Roll call: 2 yeas. Finkel corrected the written amount of conditional permits for the Zoning Board of Appeals from four as reported to five. Charges and checks (8104-8114) totaling \$8,932.93 were approved for payment.

Jed reported: Kathy Frambaugh replaced Amy Szmania on the Water Board. She made a motion to replace the legal team. The motion was not allowed because of a rule that motions are submitted prior to meetings. LORCO doing good, trying to swap some FPA (facility planning area) with Elyria. The swap might happen.

Roll call: 2 yeas.
- **2018-26** *Motion* by Lamb with a second by Rollin to authorize 10% health care premium charge for any Elected Official who elects coverage through the Township. Roll call: 2 yeas.
- **2018-27** *Motion* by Lamb with a second by Rollin to authorize plowing Findley State Park access driveway if requested. Roll call: 2 yeas.
- **2018-28** *Motion* by Lamb with a second by Rollin to authorize moving September Trustee meeting to Tuesday September 4, 2018 in honor of the Labor Day Holiday. Roll call: 2 yeas.

Motion by Lamb with a second by Rollin to continue website and Facebook maintenance with Cravener Creative through 2018 and same rate. Roll call: 2 yeas. Discussion on adding to the annual list of resolutions.

Rollin reported: Friday January 26, 8:00-9:30 Thrive meeting will be held in Huntington, Dimitri has it on the schedule and will contact Dottie Pogorelc to discuss set up requirements. Fire Department banquet coming up.
