PUBLIC Mayor Winters opened the meeting to comments from the Public. **COMMENTS:**

William Cogwell (State Route 55) asked for an update on the well litigation.

Attorney Chapman said there are two pending cases, one that the Village filed in 1995 and one filed against the Village in 2001 by Mobil Oil. He said the Village is being represented by Sive, Paget and Reisel (from New York City).

William Cogswell said it was his opinion that these suits should be pursued because the Village has lost millions of dollars over this matter.

Richard Martinkovic (Eagle Drive) discussed the Liberty Bike Trail (also known as State Street) and the fact that he would not like to see it closed off due to the fact that he and his neighbors own nine (9) building lots on it and would like access to them.

Mayor Winters said that he is planning on blocking the Spur Street side with concrete barriers and the Chestnut Street side would be left open for access.

Elizabeth Montag (Noble Street) discussed the drainage on her street and the rains that have caused problems with it.

Peter Parks (DPW Supervisor) said he would be putting in new drainage on Noble Street this year.

James Gordon (Agent for Make Hersch) complained about the sidewalk in front of the Green Building, stating that the work that the NYSDOT did is already breaking up.

Joan Stoddard (Winslow Place) discussed the bridge on West Liberty Street stating that if it is over five (5) feet in width according to the Highway Law it belongs to the Town of Liberty.

Attorney Chapman said that he would need a list of businesses where the Police Department would like to be able to write the fire lane tickets and according to Section 60-40 of the Highway Law a letter would have to be written to the New York State Department of Public Works requesting their permission to pursue this matter. Once all this is accomplished the Village Board would have to set a Public Hearing and amend the local law on this matter.

CONSIDER LOAN TO WATER FUND FOR DEBT SERVICE PAYMENT

Motion by Trustee Green, seconded by Trustee McGuire and unanimously carried approving the payment of \$115,055.03 for the Parksville Water Main Betterment, known as PIN 9066.74, contract No. D260985 which will be secured thru DWSRF funding. This payment is contingent on the proper paperwork being submitted by the Village of Liberty engineers – McGoey, Hauser and Edsall.

WHEREAS, this Change Order is for the Project Closeout and unused Contract items which have decreased the amount due to CMC Construction Group Inc. by \$9,095.90 making the contract amount \$107,909.10 rather than the original contract price of \$116,995.00;

NOW THEREFORE BE IT RESOLVED, the Board of Trustees authorizes Mayor Winters to execute this Change Order (#1).

PAST DUE LETTERS

The first letter will be a reminder and the second will begin legal action if the loans are not brought up to date.

REVISED LOAN APPLICATIONS

- > Two to three estimates per supplier (ie: Contractors, Electricians, Stoves, etc.)
- ➤ Loan Proceeds to be sent to the supplier at the discretion of the Village of Liberty and will be discussed at closing.
- File UCC on large items so they can be repossessed if the loan recipients fail to pay the loan.
- > Include home address and home phone number on the loan application.
- > Include DBA or Corporation on the loan applicant and request Certificate
- ➤ Include a line asking if the firm or individuals or any of the principals have ever filed bankruptcy and if so when and why.

- ➤ Require account numbers as well as bank information on personal accounts, with account numbers, social security number and date of birth.
- ➤ Include Personal Guarantee in the body of the application and all DBA's and Corporations will also have to sign.
- ➤ Include all trade references used in the last year, which can be this business or priors.

CONSIDER CONTINUED EMPLOYMENT FOR EDWARD LAGARDE AS BUSINESS ADMINISTRATOR

Motion by Trustee Lindsley, seconded by Trustee McGuire and unanimously carried approving Edward LaGarde to continue on in the capacity of Administrative Consultant for one more month at a salary not to exceed \$3,500. This position will be evaluated on a month-to-month basis.

Trustee McGuire thanked everyone for the work they are doing on these matters.
