1. Meeting called to order at 6:00 P.M. by Chairman Robert Parker with the following members present; Michael Riddle, David Richardson, Michael Phillips and Clifton Deloach. Also, in attendance was County Clerk Mary Ann Odum, County Administrator Chuck Scragg, and County Attorney James Smith.
2. Meeting led in prayer by Commissioner Riddle.
3. The Pledge of Allegiance was led by Commissioners.
4. Motion made by Commissioner Deloach to approve the agenda. Commissioner Riddle seconded the motion. The motion passed without opposition.
5. Motion made by Commissioner Phillips to approve the July 2019 minutes. Commissioner Riddle seconded the motion. The motion passed without opposition.
6. Motion made by Commissioner Deloach to approve to authorize payment of bills. Commissioner Phillips seconded the motion. The motion passed without opposition.
7. Motion made by Commissioner Phillips to approve the Final Plat for Palmer Place Subdivision. Commissioner Deloach seconded the motion. Commissioner Riddle opposed. The motion passed 4-1.
8. Motion made by Commissioner Riddle to authorize County Administrator Chuck Scragg to seek bids for Phase I of the capital improvements to the Old High School. Phase I includes Electrical, Plumbing and HVAC repairs. Phase II; which includes, telecommunications, internet and phone systems, and Phase III; which includes, Carpentry and Interior Furnishings. Phase IIII includes a new roof. Commissioner Deloach seconded the motion. Commissioner Richardson opposed. The motion passed 4-1 except for Phase III which will be conducted at a later time.
