

No Mystery in this Message.....

As our weather is finally beginning to improve, and people are eager to get outside and enjoy some sunshine, this renewed sense of freedom can bring with it a danger that seems to increase this time of year.....distracted driving due to texting and using other electronic devices in the car.

Spring weather can be intoxicating but drunk, drugged and distracted driving is responsible for thousands of fatalities and accidents each and every year with distracted driving now leading the pack as one of the biggest contributors to vehicular fatalities. Distracted drivers and excited children for warmer weather can lead to catastrophic events. Children running in the streets to get a ball or chase someone is abundant in the warmer months. Let's work together to keep our neighborhood out of the statistics.

Though driving under the influence poses a threat to everyone on the road, drunk driving is no longer the biggest risk behind the wheel. The National Highway Traffic Safety Administration says driving a vehicle while texting is six times more dangerous than driving while intoxicated; although neither method is a good one. The agency reports that texting while driving has now replaced drinking while driving as the leading cause of accidents and deaths of teenage drivers. It's not a problem reserved only for young adults, people of all ages admit to texting while behind the wheel of a car. Our neighborhood mornings and early afternoons are full of people walking, jogging, and waiting at bus stops. A quick distraction to check that last text message could have a long lasting consequence that just wasn't necessary. According to a Harvard Center for Risk Analysis study, texting in cars and trucks causes more than 3,000 deaths and 330,000 injuries per year.

Car and Driver magazine performed experiments by setting up cars with a red light to alert drivers when to brake. The results were surprising. Sober, focused drivers took an average of 0.54 seconds to brake. Legally drunk drivers required four additional feet to stop. An additional 36 feet was necessary when reading an email and an additional 70 feet was needed when sending a text.

Under a new Virginia law, it is now a primary offense to text while driving. For the first offense, there is a fine of \$125. For second and subsequent offenses, the fine doubles to \$250. This law applies to the operator of a passenger vehicle in motion. Driver's licenses can also be suspended for one year and jail time of up to 10 days could be mandated under certain conditions for a first offense.

The message is simple......don't do anything but drive when you're driving!

A Message From The Architecture Review Committee

With Spring approaching, we know that often means taking on exterior projects around our homes. We want to remind everyone that most architectural changes to the exterior of your home require prior approval. This can include but is not limited to: installing new siding, roofing, doors, windows, fencing and decks as well as changing the colors of your trim, shutters, gutters or front door, and removing trees. We have worked to make information easy to obtain through our website www.hiddenbrookhomes.org regarding the process and specifics on what is, and isn't, permitted. You can also easily print the guidelines and application from the website.

As was mentioned in the August 2013 Mainstream, new ARC guidelines have been drafted. They are currently under review by our attorneys, and after they are returned to us, they will be posted to the website and time will be set aside most likely in the March or April Board meeting for homeowner input; we will make an announcement in advance. The new guidelines will also be more encompassing to include the responsibility of each of us as homeowners to *maintain* our homes. As the weather warms, please take a good look at your property and home. Do the shutters or wood trim need a fresh coat of paint? Is your siding green from algae and in need of a power wash? Are your gutters, siding, shutters securely attached to your home? Are the bushes overgrown or does your landscaping need some 'freshening up'? Once the guidelines have been approved by the board and provided to the community, the ARC committee will begin the process of inspecting all homes and enforcing the new guidelines. It is our hope that everyone emerges from this cold and snowy winter with a renewed ambition to take care of their homes and do their part to keep our community looking nice!
