The Ill Winds Of 1993

The saga of the preparations for World War III continues and as each month comes and goes, we observe new incidents that neatly fit into the picture.

As we look toward the not-too-distant horizon, we can see the dust clouds preceding the great storm. It is a time to pick up the loose pieces lying around in our lives. It is a time to examine our net worth in our efforts to please God as it relates to the Judgment He is bringing on our nation and people.

As it has been said by so many analysts, starting perhaps in 1993, we should "be tightening our seat belts because it is going to be a rough ride!" The choices given to us among the main candidates for president were zero. That is exactly what we got, zero.

As we all know, President Bush has repeatedly presented to the American people the idea that the One World Order is upon us and all we have to do is to accept it peacefully. It is obvious that more Americans than he realizes will not accept the idea of the United States giving up its sovereignty to foreigners. Certainly the news media, which obviously wants and is working hard for the One World Order, hasn't revealed the fact that most Americans don't want to lose their sovereignty. So the fight continues but is rapidly coming to a climax. How do we respond to this crescendo that we see all about us?

Realizing that perhaps Bush went a little too fast, his latest orders from those above him were several in number and were all related to calming the citizens, the military and law enforcement and yet at the same time showing the purpose of a world police force. So Bush went to West Point and spoke to the cadets. He flatly told them that we were not to be the world's police force, in direct contradiction to earlier statements made by him and by his subsequent actions. He didn't have a change of heart. Bush also went to Russia during his last days in office and signed the START II treaty. That treaty, according to the current interpretation of the Constitution, will soon be the supreme law of the land.

Another one of Bush's last orders from his masters was to send our troops to Somalia. Why did we send troops to Somalia? It is very doubtful that it was because of the starving children. No, it was something more than that.

It was the best example to be found for the idea of a one world government's intervention into the internal affairs of a country, a nation which had returned to the law of the jungle after Western civilization moved out. Here was a chance to show how humanitarian the One World concept is. It was an opportunity to test the response of the American servicemen to the idea of moving into a foreign nation, acting on behalf of the United Nations and taking orders from foreign officers. That response by the American military is already being revealed and we will cover that in greater detail later in this article. The people of Somalia, contrary to the laurels being orchestrated on TV, do not trust the United Nations nor the United States.

But now we have changed horses as of January 20th. Our new horse is of another breed but just as dangerous, if not more so, than Bush. Clinton will now receive his orders, from the same masters, to finish the One World Order. He, along with Ms. President, and their Vice President, have already shown their allegiance to that cause. Clinton is a Rhodes Scholar and studied under Carrol Quigley at Georgetown. Clinton is no different than Bush. Both are striving for the One World Order.

At least within 1993 we should see a direct attack to destroy the fundamentalist Christian, the constitutionalist, the patriot, the home schooler, the Independent, and the Nationalist. Fundamentalism is not a kooky word. It means one who believes the Holy Bible to be the Word of God and that the nation which follows it will be free, prosperous, healthy and happy. It doesn't take much of an analyst to realize that we have become a nation with none of those attributes.

Bush prepared Clinton's initial major agenda towards the One World Order by sending troops back to the Mideast and once again bombing Iraq (classified as a precision surgical operation!). It provided another opportunity to test the waters for our participation in being the world's police force but, more important, it caused an increase in dissension in the Mideast. Once again, Hussein did exactly what he was supposed to do.

Word is circulating within Washington circles that President Bush transferred five billion dollars to Hussein and certain investigators are trying to unravel the story. If that is true, was it in payment for Hussein's efforts on behalf of the One World Order? Our permanent presence in the mideast is now assured and the number of troops will undoubtedly escalate in the near future, contrary to the minimal current reduction in Somalia.

We must also consider the conflict still raging within the old Yugoslavia. The United States, as the world's police force, is not spending too much time there. It is intentional that the Moslems in Bosnia are ignored.

Because of the extreme mauling that the Moslems in Bosnia are taking and that the western nations are talking about but not acting on the Islamic peoples of the world are being forced to consider their long-awaited Jihad. (holy war). The Moslem countries within Russia, along with China and a large percentage of Asia, will support the Jihad. They are not-so-quietly preparing. Some of these nations now have some measure of a nuclear capability because of what has been purchased from Russia and China and this changes the balance of power structure a great deal. It would not be in the best interests of instigating World War III if the western nations reacted too quickly. The world must wait until the right amount of carnage and destruction has occurred.

We now know that Saddam Hussein has caused the death of more Moslems over the past two years than any other person in the world. He is being payed very well for doing just that. Consider also the war several years ago between Iraq and Iran. Iraq was, supported by the West, especially the government in Washington. That was a war of genocide against the fundamentalist Moslems of Iran.

Now, a switch is made. The Moslems of Iran are being allowed to rebuild their military and Hussein of Iraq is being goaded into allowing the senseless deaths of the Moslem population in that country. It is planned that way.

One might think that it was sheer stupidity for Bush to attack Iraq again, and particularly Baghdad, at the exact time when a major Islamic conference of the world's leading Moslems was being conducted. Think of the hatred for the West, especially the United States that was generated when the attendees of that conference (all world Moslem leaders) had to dive under their tables because they were being bombed. They were already

there because of the excesses against their people and were undoubtedly contemplating the Jihad. Stupidity aside, there was only one reason for the bombings. Saddam invited the Islamic leaders to the conference while agitating the West through the UN to make the attack. It is an intentional conspiracy to cause the Moslem world to rise for their Jihad and it will be directed initially against Israel. That is the reason for the increased presence of troops from the West now in the Mideast.

The reaction is exactly as expected. Syria and Egypt are denouncing the bombings even though heretofore they were opposed to Saddam Hussein. Jordan is openly displaying its disgust for the action. Russia, on behalf of its Moslem population, called for a Security Council meeting. Islam is moving.

So Islam is preparing and their initial target will be their age-old enemy, Israel, along with those who blindly support them with no regard to their own nationality and sovereignty. Foremost among such countries is the United States along with England, France and Canada.

In the [last issue](#) we discussed the nationalism that is being displayed in Germany as they rejected the excessive immigration being forced on their country. Some of the western nations dutifully and immediately pounced upon the German youth for their acts of "racism." We printed the editorial found in *The Social Contract* magazine, which revealed the viewpoints of many political analysts. The consensus appeared to be that letters to the editors and congressmen don't get action but that "one must torch a few buildings and break a few heads." Even the *U.S. News & World Report* stated, "Skinhead violence resolved the problem where bureaucracy could not."

Apparently they were right. The German government in Bonn ruled that the refugee laws would be reconsidered in such a way that would prevent "refugees" from going through another country without stopping on their way to Germany because of the increased welfare in Germany. The refugees would be forced to stop in the first country they entered instead of going on to Germany. This is a clear victory for those Germans who wanted to stop the "open-door" policy. But, alas, here in the United States, such "racists" and "separatists" would be in the "hole" in prison or shot through the head.

We are all fully aware that the masters behind the thrones in the Christian West realize that world political control can only be accomplished by first establishing a world economic order. If the world's people can be made to believe that it is to their best economic interest to be globally interdependent, it would then be a simple matter to include a world political union. Thus we see the extreme effort, even with the direct opposition of the majority of the people, to force the North American Free Trade Zone concept, the European Economic Community and the Asian Economic Alliance.

Lesson In History Part 21

Lesson 21 is a continuation of the efforts of many very wealthy families from the countries of Europe, known as the Oligarchies (ruling by an exclusive few), to destroy the Republic of the United States. The Civil War, conceived before 1800, was to be their instrument of destruction at the expense of the people of both the South and North. That conflict between the oligarchies and the American citizens has never subsided. The war still rages but it becomes increasingly easier for the oligarchist with each passing year as the United States is filled with people who have never known the joy and obligations of living free.

Before we continue with this saga of freedom versus slavery, we must correct a misstatement that was made in [Lesson 19](#). Two dedicated students of the Civil War pointed out that Jesse James was a young lad at the time of the insurrection at Fort Sumter. We misread a statement made in one of our reference books and we must correct the error. The two gentlemen are correct!

Quoting from the book *The Unseen Hand* by A. Ralph Epperson we read on page 154, "One of the members of the Knights of the Golden Circle was the well known bandit Jesse James, and it was Jesse's father, George James, a Captain in the Southern Army, who fired the first shot at the fort." So Jesse was too young to be active at the time. Then, on pages 162-163 of the same book we read, "One of the groups acting to incite the riots was the Knights of the Golden Circle, whose war-time members included John Wilkes Booth and Jefferson Davis, the head of the Confederacy. Another member, Jesse James, was secretly hoarding large quantities of gold stolen from banks and mining companies in an attempt to buy a second Civil War. It has been estimated that Jesse and the other members of the Knights had buried over \$7 billion in gold all over the western states. Jesse James (was) a 33rd degree Mason." End of Quotes from *The Unseen Hand*.

We will continue with the saga surrounding the Civil War with more information on Jesse James and other famous desperadoes of the West following the war.

Jesse and his band appeared to be in nearly every state of the near West (Front Range and eastward) in his exploits to secure money for continuing the Civil War. We have already shown in past lessons that Mexico figured greatly in the plan of the Oligarchies to create their own empire out of a part of the United States. Caleb Cushing, working for the Oligarchies, worked the dialectics and then the double-cross when he incited the War with Mexico, knowing that Mexico was to be a part of the Golden Circle Empire.

One of the Knights first efforts in the West was to distribute, and hide, the gold that was removed from the Confederate Treasury in Richmond, Virginia before the Union Forces could get to it. It was taken to Atlanta and then distributed throughout the West by the Knights of the Golden Circle. This money was to be used to reopen the Civil War at the right time.

Jesse James, Frank James, Cole Younger, Bob Dalton and Frank Dalton were all members of the Knights of the Golden Circle. All of these men, and the men who rode with

them, were robbing trains and banks to obtain more money with which to start a new front in the West.

Jesse spent considerable effort and time along the border with Mexico in both Texas and New Mexico. He was known to visit the headquarters of the famous cattle baron John Chisum, which was along the Pecos River. We can deductively associate his friendship with Chisum to mean that John Chisum was also a part of the plot.

In [lesson 20](#) we learned that Billy the Kid worked for Alexander McSween, the Englishman John Tunstall, and John Chisum during the Lincoln County, New Mexico War which made Billy the Kid famous. We showed that the Lincoln County War was a fight between the Cattle Barons (really an oligarchy in itself) and the smaller ranchers and farmers. What this means is that Billy the Kid, knowingly, or unknowingly, fought for the same cause that the Knights of the Golden Circle did. These men weren't common bandits after all. They were soldiers fighting for a cause. Boys, in those days, were men at the age of 14 and that included Jesse James and Billy the Kid.

Another part of this drama of the desperadoes that is not commonly known is the part that Mexico and the Mexican Catholic Church played in supporting the Knights of the Golden Circle.

Mexican Nationalists wanted the Southwest territories, which were obtained under duress by the [1845 Treaty of Guadalupe Hidalgo](#), returned to Mexico. Apparently these Mexican Nationalists weren't aware of the part that the Oligarchies played in the loss of the territories in the first place. In any event, Mexican Nationalists worked with the Knights and considerable gold and silver was sent into the United States from Mexico specifically for the purpose of adding to the horde for the reopening of the Civil War. The Catholic Church in Mexico, at least on several occasions, provided the wagon trains heading North into the United States carrying the gold. It is reasonable to suspect that Jesse James, and all of his followers, assisted in the transporting and hiding of that gold. These numerous caches are scattered all the way from the Mexican border North into Canada and if they have ever been found, nobody knows about it. Historians, treasure hunters and the government are still working hard to find them!

The driving force behind the confederacy wanted the Western states because of the gold and silver ore known to be there. It takes money to feed an insurrection or civil war and the best way at the time was to take over the producing mines and also to liberate money from the banks. That was exactly what they tried to do. The Confederacy, under General Sibley (also a Knight) moved into New Mexico from Texas, hoping to liberate the mines in that state. They then moved North with the thought of taking over the extremely rich gold and silver mines of Colorado. It was their intention then to move West and take the mining areas of Arizona and California. But they got no farther than Glorieta Pass in Northern New Mexico. General Sibley was forced to retreat into Texas.

However, the intentions remained after the war. The viciousness of carpet-bagging extended into the Western Territories and there was considerable retaliation with violence and bloodshed common. Thus we see further justification on the part of the desperadoes to do their thing. The famous United States Cavalry, according to most historians, was in the West to protect the settler from the raiding Indians, particularly the Apaches. This was greatly so but it was the Apaches who upset the plans of the Knights of the Golden Circle to a great extent. The wagon-trains of gold and silver were attacked by the Apaches, not for the gold but for the guns and powder that went with the trains. The Knights would then have to retrieve what they could of the gold and silver, all of which materially affected the

outcome. If the Indians hadn't attacked the settlers, the Cavalry wouldn't have been so visible in the West. The history of the Civil War might have read a little differently!

The Civil War was over and the Knights of the Golden Circle couldn't reorganize with enough money and manpower to open up a second front. However, the idea of an Oligarchy within the United States was never lost. Patrick Henry "smelt a rat" in the days of the Federalist Party of Alexander Hamilton, Robert Morris and others, and he openly spoke against the idea of an Oligarchy. Had he been alive during the period following the Civil War, he would have again taken to the pulpits to warn Americans of a new Federalism that was determined to prohibit the private ownership of the public lands of the Western States.

President Lincoln developed the system of homesteading vacant Western lands by individual families. The system was simple. The husband, as head of the family, could apply for a 160 acre tract of his choice within suitable areas for self sufficiency. The system would have been a success and still be in use to this day had it not been for men like Henry Adams, Lawrence Oliphant, Major John Wesley Powell, Theodore Roosevelt and organizations such as the Cosmos Club and the old Smithsonian Institute. All of these men and organizations worked tirelessly to keep these "squatters" out of the Western States. It was done for purposes of oligarchy but in the name of environment and conservation.

Numerous qualified men traveled the West and reported to the lawmakers the tremendous wealth in natural resources. There was water, forests, coal, minerals and extensive grasslands. Major Powell was ordered to make a survey. He returned to Washington and belittled the earlier reports as extravagant. So Congress appropriated money for Powell to survey selected regions for irrigation canals. Powell said that five to seven million dollars would suffice and it would take six or seven years. Congress requested that he get started on one-half million dollars. Powell stated that there were not enough trained men to adequately use that money. Powell was obviously playing a delaying game, all under the direction of the Cosmos Club and the merry old English Oligarchies.

Based upon that simple ploy, President Grover Cleveland reversed President Lincoln's homestead program by claiming that all homestead claims filed after October 2, 1888 were invalid. Over one and one-third million square miles of Western lands were instantly removed from future settlers.¹

All of this was a delaying action. As we know, the Western States have been developed with irrigation systems. But the delaying actions of Powell and his cohorts allowed the time for another phenomenon to develop, that of environmentalism.

The West was too valuable to be wasted on private families. The Rocky Mountains contained natural wealth in quantities unequaled in any other part of the country. The establishment speaks truthfully when it is said that these beautiful Western lands must be preserved for future generations. It is not stated as to whose generations it is being saved for. As we will see, it is not for those the environmental ads on television depict! The banners of "Save the Planet," "Save Mother Nature," "Green Peace" and all of the other so-called conservation scams are for a political purpose. The World Wildlife Fund, for example, is headed by Prince Philip of Britain and funded by multinational oil companies.

The relationship between the oligarchies and their lackeys with the occult is astounding! Included among the associates of Henry Adams, the Cobden Club, the Cosmos Club, John Powell, as well as the majority of the rest of them, was a man from Switzerland named Carl Jung, the author of Jungian psychology. Dr. Jung's concept was to use hypnotic suggestion to attack the near conscious mind as a person is going to sleep. Suggestions made during this period are immediately acted upon in the mind, according to Carl Jung and his associates. It is important to note that the group manipulating the future of America's West

belonged to that discipline. Also, according to the book, *Prince and the Paranormal: The Psychic Bloodline of the Royal Family* by John Dale, Prince Charles and his ancestors for many generations have also been involved in this occult! It is all a part of the secret societies.

So the West was temporarily closed with one and one-third million square miles removed from homesteading. Shortly thereafter, a Congress which was perhaps still at that time for the people, reversed Grover Cleveland's edict. Incidentally, or coincidentally, President Grover Cleveland was the lackey of the same families of Oligarchies that started the Civil War.

The conspiracy was forced to use another tack in the denying of private ownership of the majority of the Western lands. They decided that the forests needed to be excluded from private ownership. This was a brilliant move on their part because it allowed for a myriad of ongoing programs that have now placed the West in a stalemate between the Federalists and the private citizen. The techniques for control and exclusion developed by the Forest Service have now been utilized by their sister organization The Bureau of Land Management which "owns" the federal property which is not included within the National Forests.

President Cleveland again reversed the will of Congress and announced the setting aside of 21 million acres for forest reserves in Wyoming, Washington, Idaho and Montana. This was just a start. During President McKinley's term, additional huge acreages were set aside. Again, the influence of Henry Adams and associates was felt. The Secretary of State under President McKinley was John Hay, who was considered the best friend of Henry Adams! He co-signed the executive orders.

Gifford Pinchot, the father of the United States Forest Service was trained in England by the British East Indies Company officials. Thus, we see the type of thinking that Pinchot used in the development of America's national forests. His indoctrination in the very purpose of the national forests was obtained there in England from the Oligarchies.

Mr. Pinchot enjoyed a special relationship with President Theodore Roosevelt after President McKinley was assassinated. It is interesting to note that McKinley was vehemently opposed to Theodore Roosevelt running on his ticket as Vice President. Powerful pressure was put on McKinley to allow Roosevelt to be on his ticket.

The old Bureau of Forestry was converted to the United States Forest Service under Gifford Pinchot in 1905, the name that it now has. During Theodore Roosevelt's administration, the national forests increased from 42 million acres to 172 million acres. Pinchot utilized the training he received in England to the fullest. The United States Forest Service now owns nearly 250 million acres and they are confiscating adjacent private land continually. There is a reason for this.

The Forest Service does not want the cutting of trees on their property. They have reluctantly allowed smaller operators to cut timber through the years but at prices that eventually forced the timber operators to quit. Constant harassment caused many of the smaller operators to give up in disgust.[2](#)

However, the Oligarchies own huge tracts of timber throughout the forests of America. The Northern Pacific Railroad, in 1906 was owned by James J. Hill, who was a very close personal friend of F.E. Weyerhaeuser of St. Paul, Minnesota. The two of them had a very close mutual friend named Cecil Rhodes of South Africa. Yes, the same Cecil Rhodes, friend of Andrew Carnegie, and founder of the Eastern Establishment's One-World-Order and the benefactor of the Rhodes Scholarship of Oxford, attended by Willie Clinton.

Mr. Hill of the Northern Pacific Railroad, and his close friend F.E. Weyerhaeuser, arranged for a shipment of Oregon and Washington lumber to be sent to Cecil Rhodes in South Africa. This was a "courtesy" shipment because certainly South Africa had its own timber.

Just to show its appreciation, the United States government allowed F.E. Weyerhaeuser to purchase 800,000 acres of forestlands in Oregon and Washington at a price of \$6 dollars per acre. This allowed the Weyerhaeuser company to be one of the largest lumber producers in the country.

Naturally, Mr. Hill of Northern Pacific Railroad, also a huge timber property owner, and Weyerhaeuser, agreed wholeheartedly with the closed forest concept of Gifford Pinchot and the environmentalists. They both went from town to town stumping the purity of principles that the Forest Service was promoting.

Another name accepted into the Oligarchies was that of the Harriman family. They, too, were in railroading by privileged action on the part of the government. By the usual practice of accepting alternate sections along the proposed railroad, the owner of the railroad sold the excess lands to obtain the money with which to build the roadbed.

Edward H. Harriman, son of W. Averell Harriman, bought the Southern Pacific Railroad in 1901, of course using monies gained by his father, who was also in the railroad business. The Southern Pacific had owned huge tracts of timberland in the Pacific Northwest. The excess lands above that needed to build the railroad was mandated by Congress to be sold to settlers at a price not to exceed \$2.50 per acre. Harriman cheated. He did not sell over two million acres of prime timberland, as directed.

The settlers in Oregon and Washington were furious. After much civil unrest, the government simply took back the land. The settlers didn't get to purchase the land as originally directed by the federal government! The railroad had been built, the United Forest Service increased its holdings contrary to the law and the settlers lost a chance at their American dream.

This encroachment in the Western States upon the private ownership of property has been insidious and there is a end purpose for it. It is highly probable that even some of the members of Congress do not know the purpose behind all of this land grabbing and the incessant drive for reacquiring the ownership of the prime natural resources. They should be in a position to know or learn so there is no excuse for their ignorance.

In later years, the government has had to be content with the confiscation of smaller tracts, sometimes just a rural store, a cafe, or a private home but it is always property they "just have to own." The Pine Springs Cafe in the Guadalupe National Park in West Texas is a typical example. The private property has been in the same family for a long time. This private property has perhaps the best drinking water in the immediate area. The government wants that water. Court hearings have been held but the government won't back down. Citizens from a wide area have gone to the site and demonstrated before government officials to no avail. Finally, the Park Service condemned the property as being unsuitable adjacent to a National Park and evicted the women, living alone, who now own the property.

It is common practice for the Forest Service to cut drastically the cattle permits held by ranchers operating on forest property. Finally, the cattle operation is no longer a very profitable venture.

Normally, water usage rights in the more arid Western States is adjudicated by what is known as "prior usage." This means the land on which the water has been used the longest

has the highest right to the water. In the parts of the country where water is more plentiful, water rights are adjudicated with the highest priority to those closest to the water source. This is known as "Riparian" rights. In more recent years, the Forest Service has attempted to use the concept of Riparian rights for ownership of the water in the Western States. Nearly 100% of the water in the Western States originates in the mountains from winter snow packs and increased rain because of the altitude. So far, the state governments have been able to hold out but it is obvious that whoever owns the water, owns one of the great natural wealths of the West.

The United States Forest Service, and their sister organization The Bureau of Land Management, have been making a systematic attempt to increase dramatically the number of wilderness areas. These so-called wilderness areas are ostensibly areas that can be set aside to be as pristine and native as they were when the nation was first founded. The first wilderness areas were pretty much pristine and native with only a small tract or two of private property, particularly a private owner who agreed to provide packing and guide services.

Then, they started to term some of these set-aside areas as "primitive." This was a step down from a wilderness area in that there were more private property owners within the boundaries. But the idea of "primitive areas" also has a future purpose.

Then, as suitable areas became more difficult to find, ordinary ranch land, and most often, mining areas were declared to be "wilderness areas." These areas are full of mines, some now abandoned, but some still operating! Very often, the decision to make an area a wilderness area is determined on the basis of the natural wealth of the area.

As an example, one such area is the Mount Wrightson Wilderness Area just South of Tucson, Arizona. This is the very area that was discussed in [lesson 16](#) as being the City of Rhoda, a part of the Empire of Calalus. This area was, and still is to this day, one of the richest mining areas in the country for gold and silver. There are still operating mines in the area and there are roads everywhere. It is not a wilderness area!

Concurrently, weekend prospectors are now being arrested for using metal detectors on government land in violation of "antiquities laws." The West is full of untold wealth, mainly in natural resources, but also in treasures hidden in past years by the Spaniards and by men like the Knights of the Golden Circle. That gold and silver must remain where it is for a purpose. What is that purpose and why has the government been setting all of this up for these many years?

It has been only twenty five to thirty years that conservation and the environment has been one of the most important social and political subjects discussed. The media is constantly reminding us of the snail darter, the spotted owl, the timber wolf, the rain forest, the green house effect, the ozone hole plus untold other issues. Jobs have been lost and entire communities have been financially destroyed because of these issues.

In a past issue of The Intelligence Newsletter we briefly discussed the World Conservation Bank. We must now discuss this issue in more detail because it is the key to the reason for the inordinate number of new wilderness areas, primitive areas, and the confiscation of private property of value to add to these areas.

The Fourth World Wilderness Congress met at Estes Park, Colorado during the period of September 11-18, 1987. Apparently there were three other such conferences held somewhere in the world before this most significant meeting. This fourth meeting was by far the most monumental because of what happened there in Colorado.

The conference itself was sponsored by Lord Exeter of England and the official hosts were designated as Emissaries of Divine Light. The name given to the hosts reflects the influence of the Jungian Psychology that has been so prevalent throughout the history of the drive for world power. The name also shows the relationship to the secret societies and to Bush's "thousand points of light."

President Ronald Reagan opened the conference with a video speech. James Baker III, then Secretary of the Treasury, spoke and discussed the importance of developing a World Conservation Bank. The stated purpose of the bank was to make available money for conservation and environmental projects throughout the world. It was proposed that the World Conservation Bank possess central banking powers, which means that it would be on the same level as the Federal Reserve Banks, The Bank of England as well as all of the world's other major central banks.

The bank was created by a decree made by Baron Edmund de Rothschild. The United Nations subsequently approved the charter of the bank in October, 1987. That was just window dressing because, Rothschild doesn't need any organization in the world to approve his actions. Rothschild named I. Michael Sweatman, one of Canada's most powerful bankers, as President of the World Conservation Bank.

There are currently member banks being formed all over the world to represent the World Conservation Bank in each respective country. Here in the United States a bank in New Hampshire named Envirobank has been formed. Its Board of Directors has named Mr. Reilly (the token "Goy") as President of the New Hampshire bank. Mr. I. Michael Sweatman is on the Board of Directors of that bank! Neither Canadian nor United States officials acknowledge that the New Hampshire bank even exists; however, there has been a Preliminary Statement printed and issued.

There are no intentions for the ordinary citizen to either invest or use the services of any of the member banks or the World Conservation Bank itself. This entire banking system is reserved for only the elite. Mr. David Lang, another international banker from Montreal, Canada and a member of Rothschild's forum which created the bank, stated the reason for secrecy and exclusiveness at the Estes Park conference. He said, "Why waste our time telling the cannon fodder which unfortunately populates the earth about this bank?"

Now, what is the scam and how does it work? The super rich of the world (generally those who are a part of the oligarchies wanting the power to control the world) will invest in the various branches of the World Conservation Bank. By using the standard fractional reserve banking techniques, these banks can loan many times more money to countries already in default on their existing loans. The United States, for example, was once the greatest lender to other nations. We are now the greatest borrower and, for all practical purposes, we are close to defaulting on the huge national debt. To show how the scam will work, the verbatim quote taken from the Fact Sheet for the World Conservation Bank follows:

"...Plans for the WCB (World Conservation Bank) propose that it act as intermediary between certain developing countries and multilateral or private banks to transfer a specific debt to the WCB, thus substituting an existing `doubtful' debt in the bank's books for a new loan to the WCB. IN RETURN FOR HAVING BEEN RELIEVED OF ITS DEBT OBLIGATION, THE DEBTOR COUNTRY WOULD TRANSFER TO THE WCB NATURAL RESOURCE ASSETS OF `EQUIVALENT VALUE.' Or, developing country debts under foreign assistance programs, which have little hope of repayment, could be retained in-country and applied toward conservation, reforestation or rural agricultural programs through the WCB."³

Obviously, there is no reason to believe that a renegotiated debt could be payed off any easier than the existing debt, which is in default. The WCB will call in the renegotiated loans at the right time and, miracles of all miracles, the elite owners of the stock in the World Conservation Bank will own huge tracts of the natural resources of the world.

Also, there is no reason to believe, what with the past track record, that our Congress would not renegotiate some or all of our national debt to relieve the current pressure of the debt. It would be a way of "selling America" to the oligarchies which, as these lessons in history have shown, is what they have been working toward since 1800!
