Diane Austin: Deian do you have anything?

Deian Longgood: Uh...yeah...I guess this brings up kind of a situation...uh...St. Andrews. Um there's been a lot of problems, a lot of complaints about my garage, you know all the issues, and whenever all this got started, you know, I asked about it with the old zoning inspector—I was told that there wasn't very many permits pulled back in and I'm not much of a complainer but uh if someone was able to go around there and look at all the stuff that's been put in there and never got a permit for it, a lot of that money could go towards the front light – eventually whoever did it—

Diane Austin: Well, actually it can't.

Deian Longgood: It can't?

Diane Austin: No. If the money comes in—you're right, when Tami went up, she found that there were things that had been done in the Highlands without permits—and like I told you, if you want to come in and fill out complaint forms on any of them at all, the current zoning inspector will start—but that money that comes in goes into Zoning and it has to stay in Zoning. So if we were to be able to do the lights for the Highlands that would come out of one of our other funds—and I explained at the last meeting, with the \$4,600, we don't have it. If they want to raise the money and donate it to the Township then we'll pay the electric bill but we don't have 46—first of all they're roads that come out onto [State Route] 14 and intersection crosses correct? They're not intersections; there are other roads in the Township as I explained, that don't have the lights so if we put them up there—it's not gonna be just \$4,600 it's gonna be all the ones that aren't – we're going to have to do that –I mean that'd be the only thing. But just so that you know, if it comes in as Zoning, we can't pull out of there for the street lights; it has to stay in the Zoning.

Deian Longgood: We're a different breed over there so we know we get different privileges. [chuckles]

Diane Austin: Some of you may think so, but no. Seriously, you are welcome to come in and meet with Julie at any time and do what you need to do because you're right.

Deian Longgood: All right. That's it. Thank you.

Diane Austin: Sure. Thanks for coming. Anybody else? [to students] You here for school? Ok, we'll sign your agenda when we're done.

One case in point is the property on Rock Spring Road where an 800 square foot house burned and will have to be rebuilt to 1,250 to meet current zoning. She attached information from Chris Meduri to her report regarding this and she will meet with the Zoning Commission after the first of the year on some possible changes.
