**I. Meeting:** Meeting called to order at 6:35 pm. November 2016 meeting notes were motioned for approval by Mike Uribe & seconded by Mike Biezad; motion passed unanimously.

**II. BRYSL Annual General Meeting:**

A. New Year Announcements

a. Danny Moreno welcomes everyone back and is looking forward to the New Year and to the new season.

B. 2017 BRYSL Board Appointments and Elections by 2016 BRYSL Board

i. Mike Biezad motioned, Carolyn Morales seconded, to accept Danny Moreno's appointments. The motion passed unanimously.

**III. BRYSL League Operations**

A. Review any changes to 2016 League Operations

a. Mike Biezad motioned, Crystal Villa seconded, to leave the League Operations as is for the 2017 season.

B. Review any changes to 2016 Team Formations Guidelines

a. Mike Biezad motioned, Crystal Villa seconded, to leave the Team Formations Guidelines as is for the 2017 season.

C. Review any changes to 2016 Rules and Regulations

- a. BRYSL has decided to update the rules and regulations regarding the Red and Yellow cards. The new verbiage regarding cards is:
  - i. Red and yellow cards shown in a game (friendly or league) shall only be punished in league games;
    1. The accumulation of three yellows card over three separate games will warrant a 1 game suspension;
    2. The accumulation of yellows will not be cleared by a red card;
    3. 1 red card = 1 game suspension;
    4. 2 red cards = 2 game suspension;
    5. 3 red cards = season suspension;
    6. The game referee has the right to rescind a yellow card or the right to downgrade a red card to a yellow card.
      - a. Mike Biezd motioned, Mike Uribe seconded, that the new verbiage regarding the red and yellow cards will be added to the new 2017 Rules and Regulations.
  - ii. For any tournament sponsored by BRYSL, teams must meet the following criteria:
    1. must have a full sponsorship (\$250 or more) by the end of league play (week 8);
    2. must have 5 separate weeks of referee points;
    3. must have a certified and trained coach;
    4. must have a certified team manager;
    5. If needed, the team referee MUST be available for tournament games or it is at the discretion of the BRYSL board to select another team for entry into the tournament.
      - a. Mike Biezd motioned, Carolyn Morales seconded, that for any tournament sponsored by BRYSL, teams must meet the criteria laid out by the BRYSL board; motion passed unanimously.
- b. BRYSL has added two new rules to the 2017 Rules and Regulations:
  - i. All sponsorships are league sponsorships and NOT tournament sponsorships or tournament entry fees. Sponsorships are non-refundable.
    1. Mike Biezd motioned, Carolyn Morales seconded, that sponsorships will not be refunded; motion passed unanimously.
  - ii. For any tournament sponsored by BRYSL, teams must meet the following criteria:
    1. must have a full sponsorship (\$250 or more) by the end of league play (week 8);
    2. must have 5 separate weeks of referee points;
    3. must have a certified and trained coach;
    4. must have a certified team manager;
    5. If needed, the team referee MUST be available for tournament games or it is at the discretion of the BRYSL board to select another team for entry into the tournament.
      - a. Mike Biezd motioned, Carolyn Morales seconded, that for any tournament sponsored by BRYSL, teams must meet the criteria laid out by the BRYSL board; motion passed unanimously.

**IV. New Business**

A. New business review with 2016 BRYSL Board

- a. Mike Radsick will look into a different insurance agency to cover our league. He will put together a side by side with our Cal South policy and we will review next meeting.
- b. The competitive league had signed up 16 players with one coming from BRYSL. They will order uniforms this month.

B. 2016 Final Standings

- a. Mike Uribe will bring the 2016 final standings to the next board meeting.
