### **ISSUE AT-A-GLANCE**

The Administration has submitted three grant applications. 1. Surface Transportation Program (STP) Grant – 2100 South Street Reconstruction (700 East to 1300 East)

**Purpose/Goal of the Grant**: If awarded, the grant monies will be used to fund the removal and replacement of pavement, the addition of curb and gutter, pedestrian improvements and incorporation of Complete Streets elements. Funds would be available during the federal fiscal year of 2024.
