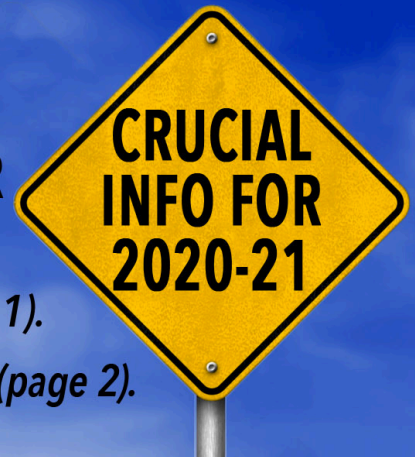


COVID-19

CLASSROOM PROTOCOLS & WAIVER



1. Please review and initial the newly established *Protocols for use of our host church facility (page 1)*.
2. Please review and sign the *Covid Liability Waiver (page 2)*.

CURRENT FRIDAY SCHOOL (AACE, INC.) PROTOCOLS: SCHOOL YEAR 2020-2021

1. Protocols may change as needed or as CDC guidelines evolve.
2. Parents and/or legal guardians MUST sign the Waiver of Liability Relating to Coronavirus/ COVID-19 before students can be allowed to attend classes.
3. Each teacher will receive a copy of these safety measures and protocols, and a copy will be posted.
4. We will use face coverings following CDC guidelines for as long as is required.
5. Teachers may be able to remove masks to teach if they are at an appropriate distance from the nearest student in class.
6. We will practice reasonable social distancing both within the building and outside.
7. Upon entering the building, the teachers, students, and parents will undergo a non-contact temperature check. If a temperature of 100 or above is revealed, then that individual will not be allowed to remain in the building.
8. Each class will have hand sanitizer dispensers available for students to use upon entering and exiting each class.
9. Before the first class begins, teachers will disinfect the tables and chairs that will be used in class. After each class ends, teachers will once again disinfect the tables and chairs.
10. Class numbers will be limited so that students can practice physical distancing in each classroom.
11. Classroom doors may be left open to lessen contact points.
12. Each class will end 15 minutes early so teachers can disinfect the tables and chairs before the next class begins.
13. During lunch, students should practice social distancing as they will be spaced out in the lunchroom area, and others may be in classrooms with an adult supervisor. (For example: 5 to 7 students could be with Mrs. Palmer in her room; another five to seven could be in the art room. The best scenario would be to have lunch outside, weather permitting and with adult supervision.
14. We will encourage "one-person-at-a-time" in the restrooms, realizing we may not be able to enforce that rule at all times and will disinfect as needed.
15. Administrators and teachers will encourage students to leave campus immediately after their last class to lessen exposure to others.
16. At the end of the day, teachers, parent volunteers, and administrative team members will disinfect all tables and chairs that have been used by Friday School participants, and the rooms will be set up for Sunday use as we have always done.
17. A parent volunteer will regularly disinfect entrance and exit points, which include door handles and doorknobs.

Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.

Alamo Area Christian Educators, Inc. cannot prevent you, or your child(ren), from becoming exposed to, contracting, or spreading COVID-19 while utilizing AACE, Inc.'s services or San Antonio First Church of the Nazarene, herein after referred to as "premises." Though it is not possible to prevent against the presence of the disease, if you choose to utilize AACE, Inc.'s services and/or enter onto AACE, Inc.'s premises, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself and/or my children in order to utilize AACE, Inc.'s services and enter AACE, Inc.'s premises. These services are of such value to me (and/or to my children), that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to utilize AACE, Inc.'s services and premises in person rather than arranging for an alternative method of enjoying the same services virtually (e.g. videoconference or Zoom). _____ (Please initial)

I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease, or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

CHOICE OF LAW: I understand and agree that the law of the State of Texas will apply to this contract.
