Contest Rules

- A \$20.00 entry fee is required.
- You must be 21 to enter.
- Limited to the first 30 teams that complete an application and pay the entry fee.
- Amateurs only.
- Only beer may be entered. No mead, cider, or wine entries will be accepted.
- Beers are to be dropped off at the designated check-in table, Saturday, October 7, 2017 between 9:00 am – 10:00 am only.
- The beer must be home brewed to entry. No entries brewed at commercial facilities will be accepted.
- The beer must be dropped off by the brewer listed on the application.
- Each contestant is required to submit 2 bottles of the same brew. Each bottle must have a completed bottle label attached.

Judging

- A panel of 3 local judges will determine the best Home Brew.
- This is a blind judging contest and all decisions are final.
- Judging starts promptly at 10:30 am, 10/7/17

Prize

- There will be a best overall brewer.
- Prize includes a gift card for Renegade Brewing Supplies in Turlock and an engraved beer mug proclaiming **GRAND BREWMASTER**.

Terms of Agreement

- I agree not to sell alcohol, food, toxic chemicals or weapons.
- I agree to follow all event rules and policies.
