

# RULES FOR MATCH PLAY 2019

## SEEDED (BY HANDICAP INDEX) DOUBLE ELIMINATION FORMAT

MUST PAY ENTRY FEE OF \$ 20.00 BEFORE BEGINNING PLAY

IT IS HIGHLY PREFERRED THAT MATCHES BE PLAYED DURING OUR REGULAR MONDAY TOURNAMENTS. HOWEVER, FOR PLAY OUTSIDE A REGULAR CLUB EVENT: PLAYERS MUST PLAY IN A CLUB FOURSOME FOR VERIFICATION PURPOSES OF THE MATCH

1<sup>ST</sup> ROUND OF PLAY WILL BEGIN MAY 20<sup>TH</sup> . DUE TO DOUBLE ELIMINATION FORMAT, IN ORDER **TO COMPLETE ALL MATCHES, THE FOLLOWING SCHEDULE MUST BE FOLLOWED** AS OUTLINED BELOW:

18 (19-IF NEEDED)	SEPT 17 – OCT 7

PLEASE SEE BRACKETS ON THE WEBSITE TO FIND WHICH **GAME #** YOU ARE INVOLVED IN AS THE TOURNAMENT PROGRESSES. THE **GAME #** IS WITHIN A PARENTHESSES: EXAMPLE: (4 : TO THE RIGHT OF YOUR BRACKET PAIRING.

YOUR TOURNAMENT SEEDING IS TO THE LEFT OF YOUR NAME IN YOUR OPENING MATCH. PAIRING & SEEDINGS ARE BASED ON EACH PLAYERS HANDICAP INDEX IMMEDIATELY PRIOR TO START OF THE TOURNAMENT IN MAY

WORK WITH YOUR MEMBER OPPONENT TO REMAIN ON SCHEDULE.

ALL MATCHES ARE HANDICAPPED. PER USGA TOURNAMENT RULES, THE MAXIMUM COURSE HANDICAP ALLOWED A PLAYER IS 36.

**EXAMPLE:** PLAYER "A" HAS A HANDICAP OF 15; PLAYER "B" HAS A HANDICAP OF 10 = PLAYER "B" WOULD GIVE PLAYER "A" 5 STROKES (1 STROKE ON THE TOP 5 HANDICAPPED HOLES) **PLEASE NOTE STROKES GIVEN ABOVE THE APPROPRIATE HOLE(S) ON YOUR SCORECARD. ALSO, PLEASE NOTE TEE COLOR PLAYED BESIDE PLAYERS NAME.**

THERE WILL BE AT LEAST 3 REGULAR MONDAY TOURNAMENT EVENTS AVAILABLE WITHIN THE ABOVE SCHEDULE TO GET YOUR MATCHES PLAYED. **MONDAY PLAY IS PREFERRED**

IF YOU HAVE NOT COMPLETED YOUR PLAY DURING THE ABOVE SCHEDULE, MATCH WILL BE FORFIETED. IF AGREED BETWEEN COMPETITORS, MATCHES CAN BE PLAYED EARLIER THAN THE SCHEDULED DATES

**IMMEDIATELY FORWARD RESULTS AND SIGNED SCORECARDS TO A MATCH PLAY COMMITTEE MEMBER AFTER COMPLETION OF EACH MATCH SO THAT UPDATES CAN BE REGISTERED IN A TIMELY MANNER.**
