Make the check for the amount of \$45.00 payable to CSE. We encourage you to add an additional tax-deductible donation to your check.** Or, use the designated PayPal button to make your payment. Because of the PayPal charge to the CSE, that charge is \$47. No matter what payment method you use, we **MUST** have your completed renewal form to ascertain accurate records for the CSE as well as for our national organization. Information submitted on the Membership Renewal Form will be used to create the members-only CSE Member Directory. Please indicate any information you do not want published.
