AMENDMENT TO THE BYLAWS OF THE CHAPMAN GROVES HOMEOWNERS' ASSOCIATION, INC.

WHEREAS, the ByLaws of Chapman Groves Homeowners' Association were adopted by the initial Board of Directors on August 18, 1994 ("ByLaws"); and

WHEREAS, Article VIII, Section 1 of the ByLaws states that the ByLaws may be amended by the affirmative vote of sixty-six and two-thirds percent (66-2/3%) of the total votes of the membership outstanding at the time of the amendment; and

WHEREAS, the Owners whose Lots are subject to the Declaration desire to make certain amendments to the ByLaws; and

WHEREAS, the necessary vote was obtained by the Owners to amend the ByLaws.

NOW, THEREFORE, pursuant to the amendment procedures set forth in Article VIII, Section 1 of the ByLaws, the following Amendment is hereby adopted:

1. Article IV, Section 1 of the Bylaws shall be amended to read as follows:

Section 1. Number. The affairs of this Association shall be managed by a Board of not less than three (3) nor more than seven (7) Directors who shall be members of the Association, except that Directors elected or appointed by the Developer need not be members of the Association. Only one person is eligible to serve on the Board of Directors for each Lot. If a Lot is owned by more than one person or entity, including husband and wife, a certificate designating the person entitled to serve on the Board of Directors must be filed with the Secretary of the Association.
