### DA\$H 4 DOLLAR\$ 2017 Futurity Rules

June 9th-11th 2017, Ogden, UT

- 1. The Futurity will be 2D with full second split.
- 2. The futurity will start at 8:00 am Saturday and Sunday. 1st go: Pre-entries followed by late entries. 2nd go: Pre-entries reversed, followed by late entries reversed.
- 3. **ALL HORSES ARE REQUIRED TO BE IN THE HOLDING PEN ~NO EXCEPTIONS**~ If you are not in the holding pen when your name is called you will be DQ. One circle is allowed
- 4. Futurity nomination & fee schedule: \$150 nomination due postmarked April 25, 2017. Payment of \$150 due postmarked by May 25, 2017. No exceptions on postmark dates and late fees.
- 5. The Futurity is open to all riders. A rider may ride more than one horse. Owners do not have to ride horses.
- 6. Dress Code: long sleeve shirt, long pants, boots and western hat or helmet is required in Futurity and all other races.
- 7. Futurity is open to foals of 2012 & 2013 (4 & 5 year olds); copy of both sides of registration papers must accompany nomination payment. Unregistered horses must show proof of age with a vet's affidavit and must accompany nomination payment.
- 8. To be eligible for the Futurity horse must never have competed in a barrel race prior to December 1, 2016.
- 9. Horse or Rider futurity substitution will be allowed for death, illness or unsoundness with a \$25 change fee and Vet / Dr. release. Notify Deb Conley 801-726-5515. Email release to rockymtnbarrels@gmail.com. Deadline for substitution & Vet / Dr. release is Monday June  $5^{th}$ , 2017, 4:00 pm. \$25 change fee must be paid by June  $9^{th}$ .
- 10. 70% of entry fee & 100% of added money will be jackpotted. All nomination fees and payments will be included in payout. Two go's and an average will be paid in the Futurity: 60% to 1D, 40% to 2D. (1st go 25%, 2nd go 25%, Average 50%).
- 11. Average prizes and money will be awarded in the futurity. Must be present or have a designated person pick up your award.
- 12. Futurity horses will be numbered and markings checked against original registration papers at mandatory check-in on Friday, June 9<sup>th</sup>, 2017 from 10:00 to 4:30 pm in the warm-up arena, please bring original registration papers to Check-In.
- 13. Late nominations may be made by paying a \$25 late fee or payment not postmarked by the due date. The last day to enter the Futurity is Friday June  $9^{th}$  2017 by 10 p.m. Late fees and substitution fees will be retained by the RMBRA .
- 14. Futurity buy-outs will be allowed with payment of the \$25 late fee and will be handled by the RMBRA. Absolutely no refunds of futurity nomination or entry fees no exceptions.

# 15. <u>Horses running in Futurity may carry over time to Open 5D, and WPRA open side-pot.</u> <u>Please fill out Dash For Dollars Entry Form and you can mail it in with your last Futurity Voucher.</u>

- 16. Stall Reservations are handled by Weber County. To reserve stalls call Tiffany at 801-643-6028. No tying at trailers over-night. Dogs are not allowed inside the barn, but can be tied to trailers.
- 17. Ground will be raked every 5 runners with a tractor and big drags will be determined. Horses will not be worked on markers, barrels are not allowed in the arena during open ride or any other time June 8<sup>th</sup>, 9<sup>th</sup>,10<sup>th</sup>, 11<sup>th</sup> 2017 except during time only.
