EXECUTIVE SESSION

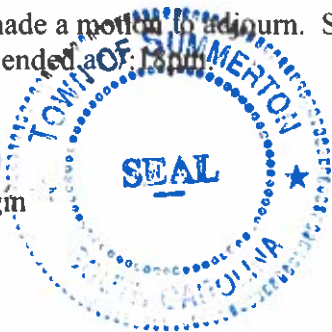
Mrs. Berry made a motion to return to open session. Seconded by Mr. Tindal, all was in favor.
