Important Paperwork: What to Keep and For How Long

If you're like most offices, you have boxes and boxes of old files cluttering your space. You'd like to clean out but don't know what you need to keep, and for how long. As a daily money manager and Certified Professional Coach, I often get this question from my clients.

When in doubt don't throw it out unless you

are sure you can obtain the records electronically from the bank, insurance company, etc.

Retirement plan statements

Keep the quarterly statements until you receive the annual summary and if everything matches up, you can shred the quarterly statements.

Bank records

Keep any checks or statements related to your taxes, business expenses, home improvements, or mortgage payments.

Bills

Keep bills until you receive the cancelled check or credit card statement showing that your payment was received.

House/condo records

Keep all records documenting the purchase

price and the cost of all improvements, as well as records of expenses incurred in selling and buying the property for seven years after you sell it.

Credit card receipts and statements

Keep original receipts until your statements come and then match them up.

Paycheck stubs

Keep until you receive your annual W-2 form from your employer(s) and make sure the information matches.

Using the above guide, you should be able to establish a system for keeping up with things over time. If the task seems overwhelming, you might want to consider the help of a daily money manager or professional organizer.
