FEATHERS IN THE WIND

According to the news, we had a pandemic not only in 1918 with the Spanish Influenza but still another one in 1969 with the so-called "Hon-Kong Flu." Because we did not have the 24/7 media coverage, nor the social media that we have today, seems things to have passed us by without us really taking notice. Ironically, the Spanish influenza did not come from Spain but from Kansas or Nebraska. The Hong Kong Flu infected some national leaders including President Johnson, who said that he had never been so sick.

Personally, I do not recall any of it (the Hong Kong Flu, no, I wasn't around in 1918!). I do recall that in the 1970s many of us went to Conroy to get injections that had been cultured in eggs. People were concerned that there would not be enough eggs around for eating. I also remember the polio epidemic of the 1950s, during which my mother refused to allow us to swim in a public pool. Still, the current pandemic is something completely different. This past Sunday, I saw a PBS program concerning camps that were set up for the Navajo people during World War II. It is ironic that the famous Navajo code talkers were Natïve Americans and that there were also Japanese Americans who would go behind enemy lines and mix up the orders that the Japanese were given. These people served even though, back in the United States, many of their friends and families were held in internment camps in the name of "national security."

While watching this program, Charlemagne wondered aloud why Germans did not face discrimination during the World Wars. Part of the reason, we figured, is because so many people are of German descent in the U.S. Actually, Germans did face some persecution during World War I, as we know from our own experience here in Amana, but it was nothing like the experiences of the Japanese Americans during World War II.

MIRINDA GORMLEY RECEIVES PHD IN EPIDEMIOLOGY

Mirinda Gormley, daughter of Dixie Trout and Dennis Gormley of High Amana, graduated from Virginia Commonwealth University School of Medicine on May 8, 2020 with a Doctor of Philosophy in Epidemiology. An online ceremony took place in lieu of a formal commencement ceremony due to social distancing restrictions imposed to prevent the spread of COVID-19. Mirinda joined the VCU division of Epidemiology in 2016, receiving full tuition from the School of Medicine while working part time as a research associate and teaching assistant under the guidance of Dr. Juan Lu. During her tenure at VCU, Mirinda's research focused on long-term outcomes following traumatic brain injury, barriers to accessing treatment for substance use disorder, the epidemiology of polysubstance use, and the evaluation of innovative interventions addressing the opioid crisis. Mirinda has presented her research at conferences throughout the United States and has published her

work in several academic journals.

Mirinda was the recipient of several academic scholarships from the VCU School of Medicine; this included the Phi Kappa Phi Susan E. Kennedy Scholarship, which honors individuals who advance the presence of women in higher education, and the Charles C. Clayton Scholarship, awarded for outstanding performance as a graduate student in the School of Medicine.

Mirinda also received a travel scholarship from the School of Medicine and a conference travel scholarship from the Council of State and Territorial Epidemiologists (CSTE). Additionally, Mirinda was inducted into the Phi Kappa Phi Honors Society in 2017 and the Delta Eta Honorary Society in Public Health in 2019. Mirinda's time at VCU came to a close on April 16th 2020 after the successful defense of her doctoral dissertation, entitled "Identifying and addressing barriers to accessing treatment for substance use disorders among opioid-using individuals following implementation of the affordable care act".

Mirinda is continuing research with her academic advisor Dr. Juan Lu while searching for postdoctoral positions that will enable her to continue her research on substance use and addiction. The rescheduled robing ceremony for the doctorate degree will be held in December.

Wesley Wampler, husband of Mirinda, also graduated on May 8, 2020. Wesley graduated Summa Cum Laude from Liberty University with a Bachelor of Science in Business Administration, which included a double major in Project Management and Economics. Wesley started his education at Bridgewater College in 2001 but left in 2003 to pursue a career as a paramedic. In the spring of 2017 Wesley enrolled in online courses at Liberty University to finish his degree. He maintained a 4.0 GPA in his coursework while continuing to work full time as a Captain of Operations at the Richmond Ambulance Authority.

Wesley will officially celebrate this achievement at his graduation ceremony which was rescheduled for September 11, 2020. Wesley is continuing to work toward earning his certification in project management and continues to work at the Richmond Ambulance Authority. Mirinda and Wes currently reside in Richmond, VA with their dog, Casey.



pool at the former Holiday Inn.

The board was not responsible for the closing of 4 restaurants, the Woolen Mill Outlet, the wine store and other businesses making the I80 Exit less of a destination for visitors and business travelers.

The county ordinance governing spending of Hotel/ Motel tax dollars requires 50% of the revenue be spent on tourism and the other 50% can go to any use. The Board of Supervisors was meeting that requirement when the law changed granting money generated in the Colonies could remain in the Colonies.

Unfortunately, relations between the Board of Supervisors and interest in the Amanas have deteriorated but I do not blame Ray. I have offered my assistance to AC-CVB officials and other organizations to go before the Board, to go with them when they go before the Board and to assist in obtaining support from the Board. Those offers were never accepted despite the fact that I still have a good relationship with the Board of Supervisors. I know Ray Garringer has been a strong supporter of the Amana Colonies and would urge you to support Ray Garringer for Iowa County Supervisor.
