PROJECT DETAILS

Application for the installation of a 20.8 kw ground mounted solar array in the RA-3 zone

Meeting # 1

Representative Brenden Rose from Plus PV gave an overview of the application. Mr. Rose stated it is a ground mounted solar system located in the rear yard of the home. Mr. Rose explained that the amount of energy the customer is producing it was not possible to install a roof mounted system. Chairperson Cartalemi went over the town code guidelines for ground mounted solar systems which he indicated the application appears to meet all the required guidelines. There was a discussion about the location of the system and if it was visible to any neighbors or front yard, Mr. Rose indicated it would not be visible. The board recommended the applicant provide the following information for the next meeting.

- Photos to be taken of the location of proposed array, from the road, coming up driveway & from the backyard facing the rear of array.
- Confirmation of the square footage of the dwelling.
- Height of the array at the tallest point.
- Screening (plantings/landscaping) plans if the array will be visible from neighbors/road. It was highly recommended that the site plan reflect screening.

With no further discussion the matter was held over to the next monthly meeting.
