HIGHLIGHTS OF APRIL 8, 2018 HOA MEETING

- The BOD approved spending \$1600 for a Reserve Study which will include a 30 yr cost study of community upkeep with detailed inventory for use in planning & budgeting purposes.
- Replacement of lost pool keys will be \$25.00. Leslye Lebakken will oversee.
- BOD approved new Fine Policy, Fruit Removal Policy and new paint palettes. (posted on website)
- Investigation of HOA Management Companies continues.

Fruit Removal Policy

As a result of a few homeowners who have not maintained their fruit trees, the ACC Committee was asked to develop a specific policy related to the removal of fruit. This policy was presented to the CdC Homeowner's Board of Directors and was adopted on April 8, 2018.

Homeowners in Casa del Cielo are required to maintain their side and rear yards in a "clean and attractive condition," including but not limited to trimming and restraining vegetation and removing refuse. (Section 4.5, page 36, CdC CC&Rs)

The failure to remove fallen fruit in a timely manner creates a significant risk of roof rats and other pests

and therefore creates a health hazard.

Upon a verified complaint, the Architectural Control Committee will send a notice to an owner requiring

unpicked, ripe or fallen fruit to be removed from his or her property within seven days.

If the owner does not respond or fails to comply, the Association will notify the owner that CdC will contract with its vendor to enter the owner's yard and remove the fruit. The owner will be responsible

for the costs up to \$250 and is subject to a fine for non-compliance according to CdC's Fine Policy. Owners may appeal to the ACC as provided in the CC&Rs.

ALERT: If you see anyone digging in your yard or nearby, we are asking that you immediately call Mauricio (602 718 9792) and leave your name and address so that he can send one of CdC's landscaping crew to be on hand to handle damage to our sprinkler system.

How to Obtain Approval to Repaint Your House in Casa del Cielo

1. Choose your colors.

 Casa de Cielo residents have their choice of using five custom paint palettes which may be found in color on the Scottsdale Ranch website at https://www.dunnedwards.com/colors/archive/color-ark_pro/scottsdale-ranch/casa-del-cielo.
You may also visit the SRCA Community Center for paint samples, or go to any Dunn Edwards store. All colors are listed using Dunn Edwards paint codes, but you may go to other paint stores and instruct them to use the Dunn Edwards colors.

Front Door Colors

The palettes can be paired with the following door colors;

2 OnlyWild Mustang, Sunken Ship and Spiced Berry

4 OnlyWild Mustang, Sunken Ship and Spiced Berry

10 OnlyWild Mustang, Sunken Ship and Spiced Berry

11-15 All door colors except Sunken Ship

13-15 Only Made of Steel, Dark Pewter, Weathered Brown and Spiced Berry

Each palette contains options for primary colors and trim colors. Primary and trim colors from different palettes may NOT be used together.

A primary color must be used for the house body color.

As a trim color, you may choose the body color, one of the primary colors not used on the body or a trim color.

The chimney and chimney cap must be painted with either the house body color or trim color, except that houses with blue tiles may paint their chimney cap a matching blue. Casa del Cielo Approved Paint Colors and Application Instructions, Page 3

3. Complete and submit an application to Scottsdale Ranch Community Association.

4. YOU MUST COMPLETE AN APPLICATION AND RECEIVE APPROVAL EVEN IF REPAINTING YOUR HOUSE THE SAME COLOR. This is the only way to ensure that your house file is up to date and for you to

know you have complied with SRCA and CdC rules. SRCA will review your application and forward it to the CdC Architectural Control Committee for its review and approval, and you will be notified when you may begin your project. Allow up to three weeks although SRCA and CdC review applications as quickly as possible.

GENERAL VIIOLATION FINE POLICY AND APPEAL PROCESS
