

<u>"360 Degree Leadership":</u> This class is designed to teach participants how to effectively manage the complex relationships inside and outside of professional organizations. You will learn how to interact with those above you, beside of you and below you in an organizational structure. Understanding the organizational "psychology" of the people is key to succeeding at high levels.
