## **Odor Recognition Tests**

ORT testing space is a large indoor, climate-controlled training facility with matting. There is a ramp at one entrance and 6 steps to exit the building. The parking lot is asphalt and minimal shade. Due to unforeseen conditions, such as weather or change in availability of areas at the location, the expected test area, parking, and/or pathways may be modified at the last minute.

**Entry method – First received By USPS Mail  
Any overnight deliveries must have the signature waived box checked.**

**Entries close Friday November 22<sup>nd</sup> at noon or when entry limits have been met.**

**Entries are LIMITED to 100 tests.**

### ***Test Site Information***

The test will be inside in a dog training facility with matting. Dogs must be crated in your car until they are being tested as there is NO indoor crating space available.

Please bring your own lunch as needed. Many restaurants are close to the facility.

All dogs must be on a 6' leash at all times when not being tested. No flexi-leashes for walking dogs on test site grounds; flexis may be used in the test itself.

### ***Entry Requirements***

The handler of the dog must be a current 2019-2020 member of the NACSW™. The Dog must be registered with the NACSW™. For information on how to register or become a member go to [www.NACSW.net](http://www.NACSW.net)

### ***Trial Eligibility and ORTs***

An ORT must be taken and passed at least 14 days before a trial opening date to be eligible for the first draw period.

### ***Entry Fee and Second Dog Policy***

**\$30.00** per dog per test. (If you enter one dog for all 3 odors the fee would be \$90 total).

Birch, Anise, Clove: one dog entry limits per handler per odor.

Please fill out a separate registration form for each dog to be tested.

### ***Closing Date***

Entries and payment must be received at the Secretary's address by Friday November 22<sup>nd</sup>, 2019 by noon. Overnight mail entries must have the signature request waived.

### ***Refund Policy***

Cancellations made on or before Friday November 22<sup>nd</sup> at noon will be refunded. No refunds after the entry closing date. Cancellations may be made by e-mail ([readytorun452@yahoo.com](mailto:readytorun452@yahoo.com)) or telephone: 215-802-0132. The test secretary is not responsible for lost e-mails or calls that do not reach her. The secretary will send an e-mail back to the participant confirming the cancellation. **ENTRY FEES** shall not be refunded if a dog is absent, disqualified, or excused by the NACSW official or judge.

### ***Video/Photography Policy***

ORT participants can have a friend or family member video/photograph their test. ORT participants are not allowed to video/photograph one another. ORT hosts are not obligated to provide someone to video/photograph.

## TEST Information - Notice to Exhibitors

**THE TEST SITE** will be open from **8:30 am**.

### ***Check-in / Handler Briefing***

Details regarding check in time, schedule and briefing will be sent approximately 1 week before the ORT.

### ***Score Books***

**Score books are optional and are not required to participate in an ORT.** They are for personal record keeping. If you have lost a scorebook or would like a replacement, you can request a replacement score book that will include all your prior NACSW results. Log in to your account at: <http://www.nacsw.net> and under the "My Account" section, go to "My Dogs" and choose the option to order a replacement score book there. The cost is \$20.

### ***Spectators***

**NO SPECTATORS ARE PERMITTED IN THE SEARCH AREA** during the ORT except NACSW™ officials, adults accompanying a minor, CNWI-in-training, or immediate family members/friends of the dog/handler team currently being tested.

Spectators that are family member/friends of the dog handler team must check in and sign a waiver.

### ***Entries:***

- TELEPHONE, FAX, UNSIGNED ENTRIES, AND ENTRIES RECEIVED WITHOUT FEES cannot be accepted.
- RETURNED CHECKS do not constitute a valid entry fee. Returned checks will be subject to a \$25 fee in addition to any fees charge by your bank.
- ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.
- OWNERS are responsible for errors in making out entry forms.
- EXPRESS MAIL entries must include signature permitting them to be left at the secretary's address without recipient's signature.

### ***Dog Policies***

Dogs will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for having it ready when it is to be judged. Be prepared to keep your dog in your car when not being tested or on leash at all times. There is no inside crating at this test location. Please pick up after your dog.

### ***Females in Season***

Contact your test host at least 1 day before the ORT if this becomes a possibility.

### ***Dog Age***

Dogs Participating in the ORT must be at least six months of age and must appear to be healthy on trial day and should be current on all vaccinations required by law.

### ***Entry Confirmation***

Acknowledgement of entry will be made via email when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry.

### ***Basic Description of Test***

To successfully pass an ORT a dog must identify the location of the target odor and the handler must correctly call an “alert” within a three-minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes set up in a pattern of *one or two* rows, spaced a minimum of 48” apart. The ORT is conducted on leash. Complete information can be obtained on the NACSW™ website.

PLEASE DO NOT SEND YOUR ENTRY & PAYMENT TO THIS ADDRESS. THERE IS NO MAILBOX AT THIS ADDRESS. PLEASE SEND TO THE TEST SECRETARY – ADDRESS is on the entry form.

### **From NJ and East**

Route 78E to Route 33 N. Take the Route 22 East Exit and turn right onto Route 22 E.

Take the 25th street exit and turn right at the light. At the next light, turn right onto William Penn Highway. Continue west on William Penn Highway to 3143. The marquee sign has Planet Fitness and Easton Hosp Rehab, we are not listed on the sign. Turn into the lot and park on the side or back of the building. Entrance is on the side of the building, Door #3.

### **From the South**

Take 78 E to Route 33 N and follow from above

### **From the North**

Take Route 33 South to the Route 22 east then follow from above

### **From the West**

Take Route 22 E follow above
