MOTION by Daley supported by Thiemkey to change item #4 of Zoning Amendment to any medical marijuana dispensary shall be at least one thousand feet from any school property line and at least 500 hundred feet from any church or library building. Committee voiced 5 ayes and 4 neyes, Motion carried 5-4.

MOTION by Listerman supported by Franz to change item #3 of Zoning Amendment to No more than one (1) caregiver shall operate out of any medical marijuana dispensary location. In no event shall more than one caregiver conduct operations on a single parcel of land.

Motion carried 7-2.

MOTION by Batzer supported by Schultz to change Item #3 from (1) caregiver to (2) caregivers.

MOTION by Thiemkey supported by Daley to approve Medical Marijuana Zoning Amendment Ordinance No. 201 with changes and recommend to the Village of Dryden Council to be placed on the agenda of the next scheduled meeting Tuesday, October 5, 2010.
