Canvas Votes from the November 2, 2021 City Election

### **Certification of Election Returns by Mayor Minton**

Yvonne Cones made a motion to approve the canvas. Curtis Ainsworth seconded and the motion passed with a unanimous vote. The total votes for Benjamin Cartright-25, Curtis Ainsworth-62, Ray Marrs-47, Kurtz Stowers-26, C Mark Porter-36. And the total votes for the Unexpired term, Hayden Irwin-76.

### **Issue Certificates of Election**

Mayor Minton issued the Certificates but due to a clerical error the certificates were collected and will be issued at a later date.

### Receive Statement of Elected Officers- Judge Harris Blanchette, Municipal Judge

Judge Blanchette was not available therefore Mayor Minton received the Statement of Elected Officers from each of the new elected councilmen.

### Oath of Office administered to the new elects- Judge Harris Blanchette, Municipal Judge

As Judge Blanchette was not available to attend, Mayor Minton administered the Oath of Office to the new elects.

### Discuss and take action on request from Chris Simmons to abandon the alley bordering his property at Smith and Bell.

Mark Porter made the motion to proceed. Curtis Ainsworth seconded and the motion passed with a unanimous vote. With the information Mr. Simmons received at the time of his purchase of this property he built a shop. A more recent survey shows the building is 5 feet into the City Alley easement. Mr. Simmons is preparing to enter a building project on his property. Mr. Simmons requested that the City abandon at least 10 feet of the alley that borders his property. The attorney informed that this is a two step process. The city may abandon the property and then issue following a survey deed the property to Mr. Simmons based on square footage value. The Council informed Mr. Simmons that he may proceed that they will agree to abandon the property requested.

Discuss and take action to request from Chris Simmons to abandon the undeveloped portion of Bell Street that borders his property.

Curtis Ainsworth made a motion following Debra's recommendation to hire Monique Wilder as a Utility Clerk with Stephanie Hopkins as the alternate. Mark Porter seconded and the motion passed with a unanimous vote.
