I (we) am (are) fully aware of the risks and dangers inherent in whitewater river running or travel upon mountain roadways such as, but not inclusive of: vehicle or raft upset or collision, exposure to inclement weather, immersion in water, ejection from or falling while on board a raft, collision with rocks, persons, equipment or other objects. Falling while on shore and/or entering or alighting from vehicles or rafts, bites or spray by insects, animals or reptiles, exposure to poisonous plants and damage to or loss of personal property.

I specifically understand that Kings River Expeditions provides foot cups in its boats to assist participants in stabilizing themselves. I understand the choice of using the foot cups is entirely up to me. Kings River Expeditions has found that participants run a greater risk of falling out of boats and suffering serious injury and/or death in the water if they elect not to use the foot cups. However, I also understand that in certain situations use of foot cups can present an increased risk of knee, ankle, or other injuries because of the restrictive nature of the foot cup. Thus I understand that there are risks of serious injury/death in rafting whether or not foot cups are used.

Knowing the risks and dangers, I (we) understand the possible consequences of participating in such activity(s) include but are not limited to discomfort, injury or loss of life.

I (we) certify that I (we) have the necessary skills and ability to participate in the said activity(s) and assume full responsibility for myself (ourselves) for bodily injury, death and loss of personal property and expenses thereof as a result of my (our) negligence in participating in said activity(s) except to the extent such damage or injury may be due to the negligence of Kings River Expeditions.

I(we) also agree to abide by the rules or instructions given to me (us) either verbally or in writing by Kings River Expeditions. I am further aware that Kings River Expeditions may take photographic and/or film records of all trips and such records may be used for promotional and/or commercial purposes.

I(we) have read, understood, and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me (us) during the entire period of participation in said activity(s).
