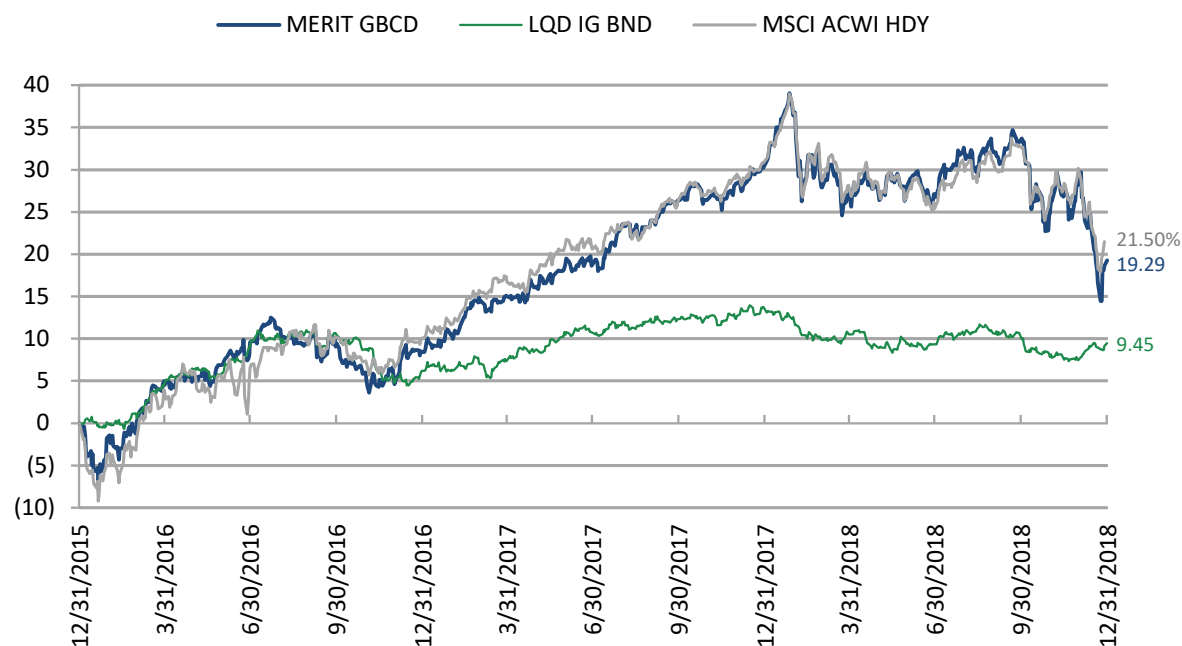

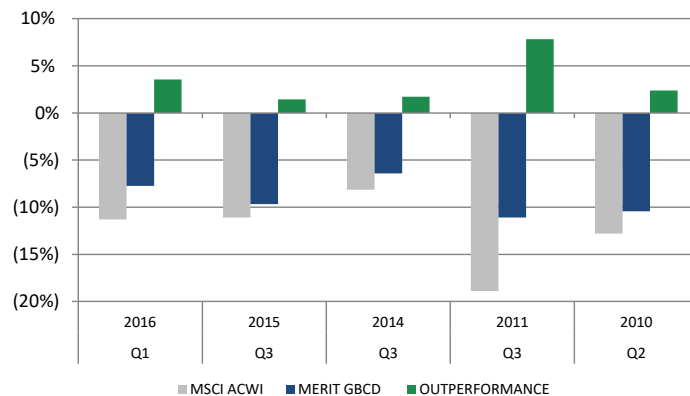

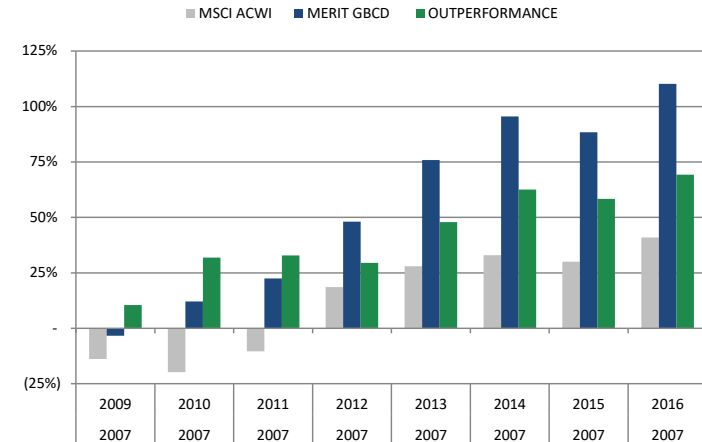
GBCD OUTPERFORMANCE DURING MARKET DECLINES

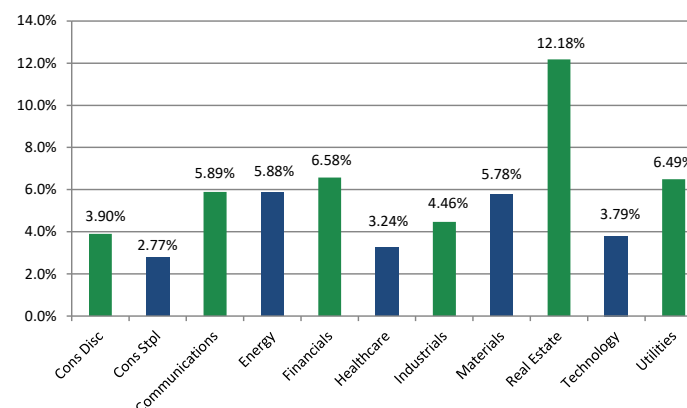

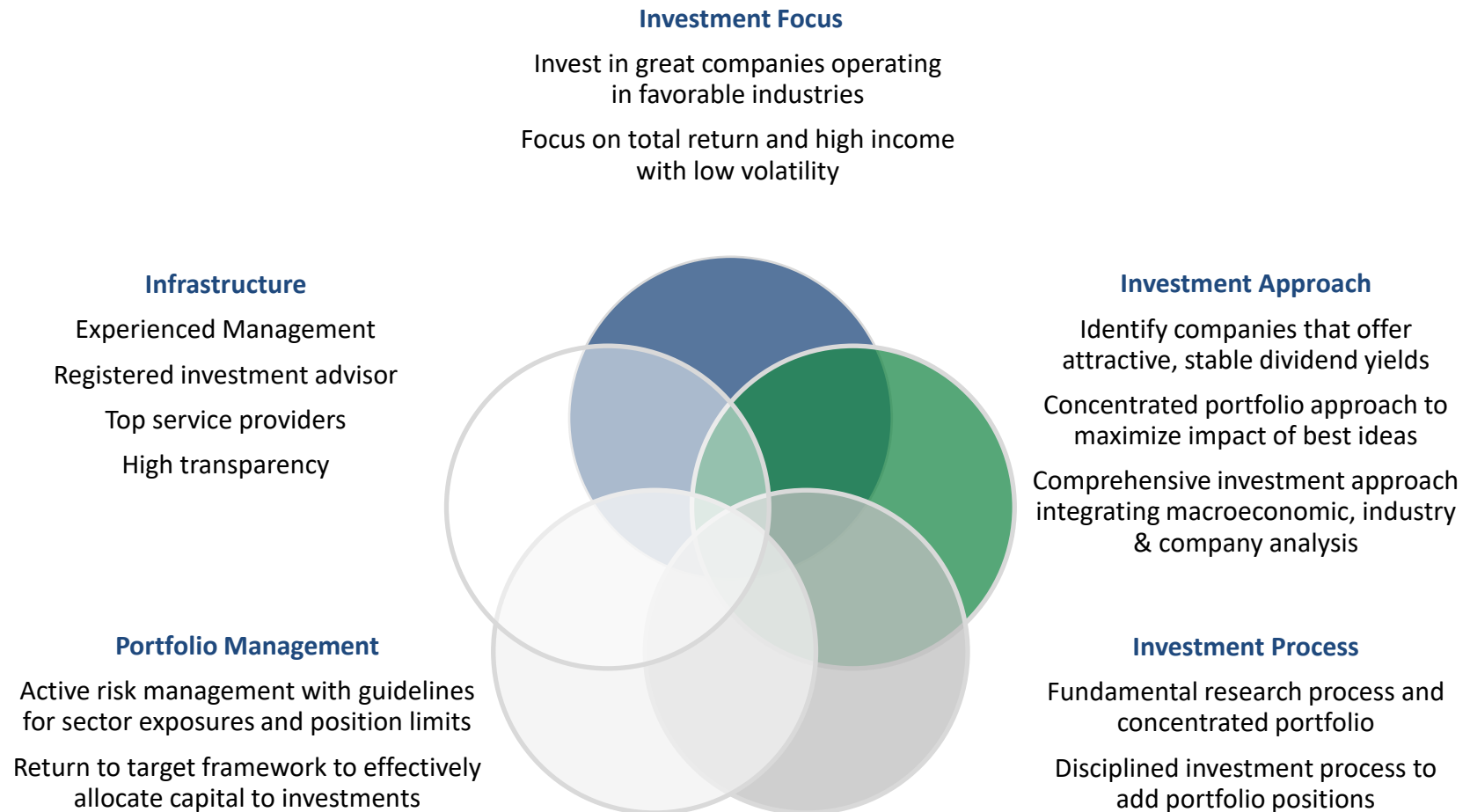
