- 2. THE PAGEANT IS OPEN TO ANY CONTESTANT WHO ENTERED THE COUNTY FAIR PAGEANT IN THE COUNTY THAT THEY RESIDE. THE WINNER OF THE COUNTY FAIR QUEEN PAGEANT IS NOT ELIGIBLE TO ENTER THE DISTRICT CONTEST AND WILL REPRESENT THEIR COUNTY IN THE ARKANSAS STATE FAIR QUEEN PAGEANT.
- 3. A CONTESTANT MUST HAVE BEEN BORN A FEMALE.
- 4. CONTESTANTS CANNOT BE OR AT ANY TIME HAVE BEEN MARRIED, PREGNANT, NOR HAVE HAD A CHILD.
- 5. CONTESTANT MUST NOT HAVE COMMITTED A CRIME OR HAVE CRIMINAL CHARGES PENDING.

- 6. VISIBLE TATTOOS SHOULD BE COVERED WITH MAKE-UP.
- 7. CONTESTANTS ONLY WILL BE ADMITTED FREE AT THE DOOR ON THE NIGHT OF THE CONTEST.
- 8. CONTESTANTS MAY NOT ENTER THE MISS NCADF FAIR QUEEN IF THEY HAVE PREVIOUSLY WON THE TITLE AT THE NCAD FAIR OR THE ARKANSAS STATE FAIR. THEY HAVE PREVIOUSLY WON.

THE ENTRY FORMS ARE DUE AS SOON AS POSSIBLE AFTER EACH COUNTY'S FAIR PAGEANT AND MUST BE SIGNED BY THE COUNTY DIRECTOR.
