## Tournament Rules

1) Bowlers are eligible to participate in this tournament if they have paid their 2019-20 USBC Membership dues thru the Greater Baltimore USBC Association (either full membership at \$23 or co-association at \$10).
2) AVERAGE RULE: Entrants shall use their highest GBUSBCA average for the 2018-2019 season. If no GBUSBCA yearbook average for the 2018-2019 season, entrant shall use their highest GBUSBCA current average for at least 21 games as of January 1, 2020. If the entrant also has a non-GBUSBCA average listed on bowl.com, their highest bowl.com average for 2018-2019 will be used for their entering average. Otherwise, entrant shall use an average of $\mathbf{2 4 0}$. If using the current season's average a written verification of this average, signed by the league secretary, must be provided to the tournament director prior to the start of bowling.
3) Prize fund shall be returned $100 \%$. Prize ratio shall be at least $\mathbf{1}$ in 10 for each event.
4) Unlimited multiple participation is permitted. USBC Rule 315 applies.
5) If a bowler has entered an event by the start of the tournament, they can enter that event again based on lane availability.
6) No more than two PBA Members shall be permitted to bowl on a four person team while no more than one PBA member shall be permitted to bowl on a doubles team. A violation of this rule will result in disqualification.
7) Entrants must enter both singles and doubles when entering minor events.
8) Singles shall be bowled first in minor events.
9) USBC Rule 319a(2), ten pin up rule, will not apply.
10) USBC Rule 319d applies. Entrant must report (in writing) all prizes which they have qualified for within the last 12 months to tournament management prior to bowling. Failure to comply may result in forfeiture of entry fees and prize winnings.
11) USBC Rule 319c (Rerating) applies. It shall be each entrant's responsibility to verify the accuracy of their average, whether originally submitted by the entrant, team captain or others. Failure to use proper average shall disqualify scores if submitted average is lower than actual average. If you have been re-rated in the past 12 months, in any tournament, you must report in writing to the tournament director prior to squad time, If not reported, it is cause for disqualification.
12) Team captain shall check in their team and be able to present USBC Membership Cards for all of their team members at least 30 minutes prior to time they are scheduled to bowl.
13) If an entry is first in both scratch and handicap in an event they will receive the title and trophy for both scratch and handicap.
14) A $\mathbf{\$ 2 5 . 0 0}$ fee will be charged for any checks returned by our bank for non-payment.
15) Late entries (after February 20th, but by February 26th) must be paid in cash at time of submission.
16) USBC rules applicable to sanctioned tournaments apply when not specifically covered by these rules.
17) The Tournament Director shall decide any questions not specifically covered by these rules.
