- 2:Annual Dues: Adults -\$100, Junior Member (18 or younger) -\$20. Members joining after July 1 will have their dues prorated at \$10 per month for the remaining year.
- 3:Assessment Fee: \$100 to be paid with the first year dues for a total of \$200. Junior Members and Wives are not required to pay an Assessment Fee.
