

#### **POSTED SPEED LIMITS**

The Association Office receives complaints routinely for people driving throughout the Community and exceeding the posted speed limits. The Louisa County Sheriff's Department has been most helpful in their attempts to resolve this problem. They have jurisdiction to write summons for speeding or reckless driving on Association Roads and the results go into Louisa County General District Court and if found guilty those results will be posted with DMV and appear on your Virginia Driver's License Records.

The Sheriff's Department has assured us of enhanced efforts to resolve these problems and will be placing Deputies in the areas of complaint. Please be considerate of yourself and others as it relates to the potential consequences of traveling too fast within the Community.

REMINDER: All Members and Registered Renters are responsible for their guests and their actions.

# Did you know leaves can harm our lake?

Phosphorus in our lake can come from leaves. Raking leaves into the lake, or water flowing through leaf piles in our streets create a "leaf tea" that is rich in dissolved phosphorus. Too much phosphorus can lead to toxic algae blooms, low oxygen levels, and green murky waters, none of which are good for animals living in the water or those of us who use it for recreation. Don't LEAF the LAKE!

#### Revision to ByLaws, Article IV, Section 2, Guests

A gentle reminder of revisions to the Guest Policy as approved by the Board of Directors during their August and September, 2017 meetings and the two bold sentences contain those revisions:

Section 2. Guests: Each Member or Non Member Occupant shall have the right to extend guest privileges, but, subject to such regulations as may be adopted by the Board. Members and Non Member Occupants are at all times responsible and will be held accountable for their actions of their guests. Guest actions may result in complaints submitted to the General Manager, Compliance Committee, or Board of Directors potentially resulting in the member incurring a fee or a loss of privileges. Any individual who gains access to Blue Ridge Shores via the member access in any manner shall be considered the Member's guest. Any member or Non Member Occupant extending guest privileges will either accompany their guests to the common area being used or send an email to the office with the guest's name, number of people with them and type of vehicle being driven. Visitors not accompanied or identified by email will be asked to leave by the General Manger or his/her designee.

Every drinking water system is mandated by the Virginia Department of Health to have a cross-connection/backflow prevention program. RU has a pamphlet outlining our backflow prevention program. Copies can be obtained from the office as well as online at www.ridgeutilities.com. You can also purchase a vacuum breaker from our office to help aid in your own personal backflow prevention.

#### 2nd Quarter 2018 Meter Reading

During the third week of June our Maintenance Department will begin reading meters for the 2nd qtr. of 2018. Please be sure there is nothing obstructing your meter box, such as shrubs, flowers, lawn decorative items, etc. Please do not park vehicles on the meter boxes. You will be responsible for any damage incurred to a meter box if you park a vehicle on it. The meter boxes are the property of Ridge Utilities, Inc. and must be accessible at all times to Ridge Utilities, Inc. and our staff.

# NO WAKE ZONES SPEED LAWS

**Dept. of Game & Inland Fisheries** 

"No Wake" is defined as the slowest possible speed required to maintain steerage and headway. It shall be unlawful to operate any motorboat greater than no wake speed when within 50 feet or less of docks, piers, boathouses, boat ramps, and people in the water. This definition does not prohibit the pulling of a skier with a rope of less than 50 feet, nor a person accompanying the motorboat (wake surfing) provided the motorboat is propelled by an inboard motor.

**SLACKEN SPEED:** Operators shall reduce speed to avoid endangering persons or property by the effect of the motorboat's wake when approaching or passing vessels under way, lying to, or made fast to the shore; or when approaching or passing persons in the water or using water skis or surfboards.

**SAFE SPEED:** A safe speed is a speed less than the maximum at which the operator can take proper and effective action to avoid collision and stop within a distance appropriate to the prevailing circumstances and conditions. In establishing a safe operating speed the operator shall take into account; visibility, traffic density, ability to maneuver the vessel (stopping distance and turning ability), proximity of navigational hazards, draft of the vessel, limitations of radar equipment, and the state of wind, sea, and current.

#### **BOAT REGISTRATION**




#### **DID YOU KNOW?**

#### **General Manager's Report**

We hope you enjoy your summer and look forward to serving the continuing needs of the membership during the 2018 season. Boat decals may be purchased @ your convenience once you have paid the first half of the 2018 assessments. You cannot purchase gas @ the marina without a current decal. Remember that gas powered motorized boat traffic is only in a counter clock wise direction unless you are fishing and under the power of a trolling motor. Our Special Assistant to the GM, Joe Sprouse will be on the Lake enforcing the boat policies and attempting to maintain a safe environment for all. Remember: "It shall be unlawful to operate any motor boat greater than no wake speed when within 50 feet or less of docks, boathouses, piers, and people in the water."

Congratulations to William S. Earhart, David Kronander, and Mary Mainland for being elected to serve a three year term on the BRPOA Board of Directors. Same wishes to Molli Ellis, Alex MacCormack, and Steve Tompkins for being re-elected to serve on the RU Board for a three year term! We pledge our support to all!

Lake water quality samples were recently taken to the lab in Culpeper to be analyzed. All tests came back well within acceptable ranges for swimming and other related activities. This will be done monthly during the summer-fall season.

We urge members to be considerate of others during your visits to the beach. Please do not leave cigarettes in the sand rather place them in a container and dispose of them properly. Same rule applies to food and beverages. There are no glass containers or alcohol permitted on the Beaches! Rules of the Beach are posted and we respectfully submit they apply to everyone. More than adequate trash cans are available. Ridge Utilities furnishes water for the bathrooms and outside faucets, so please be considerate and do not let children play in the streams or leave them on once you have cleaned the sand off your feet.

WE seek your cooperation when leasing the Community Center; do not place a grill on the front sidewalk closest to the Lake. Someone did and it has those grease marks remaining!

Often during a leak within RU'S water mains there is not time to provide advance notice, and I know of

no solution for that issue. When we plan on having a particular section or an entire street's water off there will be either a mass email or a grouping of impacted members notified. Remember; when you notice that the water is off, turn the breaker off that is for your water heater.

I urge those that wish to sign up for a partial payment agreement to do that soon, in order to avoid higher monthly payments. To date we have approved twenty. We have collected approximately 80 % of the 2018 revenue affiliated with assessments and occupancy fees by the end of April, 2017. There will be a Members Not in Good Standing hearing scheduled in August for those that are making no effort to pay their assessments. The normal collection process will be implemented in the first week of July. The Associations delinquency rate for 2017 was 3%.

Remember nothing can be placed in the Lake including leaves without Board permission. If you notice a boat on the lake without BRS decals, please call the office immediately if open. There are those that are slipping in and fishing from the lake without being a member.

Ridge Utilities is very pleased to announce that all required 2017 testing of the water was completed with a 100% passing of those requirements. The official 2017 Water Quality Report was distributed recently by US Mail and if you do not receive yours, contact the office for a replacement.

When you order materials for a project, have your septic system serviced, have LP gas delivered, or order new furniture, it is very important to inform those companies NOT TO CROSS THE DAM AREA! Those vehicles are in excess of the 5 ton limit posted for that area. We ask all members who witness a vehicle you believe to be in violation to report that information to the office with their Company name.

Should you witness any activity that appears unlawful contact the Sheriff's Department immediately and also make the office aware of the issue including tag numbers, type of vehicle, and if by chance you know the individual(s).

#### 2018 Boating Policies and Safety Tips

Boating Season is here and we hope everyone has a 2018 Fun but Safe experience. Blue Ridge Shores adopted the provisions of the **Virginia Boating Safety Education Requirement** for operation of a motorized boat on Lake Louisa. The Virginia Conservation Police Department has authority to enforce all provisions of State Requirements on Lake Louisa. Just a few reminders for everyone:

- Anyone operating a motorized boat in Virginia must possess a card indicating they have taken the Virginia Boater Safety Education Class or the State's Safety Class where the boat is registered.
- · Operators must be at least 14 years old.
- Boats must be registered to a member or a non-member occupant who are members in good standing.
- All motorized boats must be registered through the office with current State Registration and Insurance Information in order to have and display a current Association Decal.
- All Non-Motorized Boats excluding a paddle board must be registered through the Association and display the appropriate decal.
- Jet Skis and jet powered boats are not permitted to be on the lake. Jet powered boats registered with the Association prior to August 13, 2011 are exempted from this rule.
- All motorized boat traffic must travel in a counter clockwise direction, unless they are fishing and under the power of a trolling motor.
- All boats that are non-motorized have the right of way.
- All fast moving boats are required to stay off the Shoreline by 100 feet.
- All boats pulling tubes, skis, aqua boards or any other object are required to have a spotter. These activities are limited from 9:00 AM until sunset.
- All boats are to have running lights or navigational lights after dusk or before dawn.
- The Association's Special Assistant to the GM is patrolling the Lake and will issue violations as appropriate and the member affected will be required to attend a Compliance Committee Hearing.
- Should you have questions, require clarification, or a copy of these rules please contact the office.

#### **Virginia Boating Safety Class**

<u>Section II, Policies, Rules, and Registration; D. Boats</u> requires that all Motorboat Operators complete this class or an equivalent and present proof of Compliance to receive their boating registration. This policy was phased in since 2011 and

effective July 1, 2016 all operators of motor boats regardless of age, had to meet the requirements. If you have completed this class in another State and have that certificate of completion, it will meet the BRS requirements. An operator under direct supervision of an individual who has met this requirement is not required to take this class.



The Office cannot issue 2018 registration/decals unless the above requirements are met and a copy of completion is submitted for your file.

# RULES of THE BEACH

- Use of the beach and other facilities are for BRPOA Members,
   Nonmember Occupants, & Guests
- Swim at your own risk, no lifeguards on duty
- No diving from the seawall or marina
- No dogs or other pets on the beach
- No Alcoholic Beverages or Glass Containers Permitted
- Use of a grill beyond the chain and posts/parking area is not permitted
- Children under 12 MUST be accompanied by Parent or responsible person at least 16 years of age
- BEWARE: Many areas of the lake are more than 5 feet deep and are dangerous for children, non-swimmers, and poor swimmers.
- · Swimming beyond the post areas is discouraged.
- Manager on duty may ask any person who acts in an unsafe manner or who violates the Regulations applicable to the beach and swimming areas to leave the area.
- No loud or offensive music will be tolerated.
- REGULATIONS ARE AVAILABLE in THE ASSOCIATION AREA
