Minutes of July 6, 2020

The Huntington Township Trustees met in special scheduled session at 6:45 PM at the Township Hall. The advertised purpose of the meeting was to present the 2021 budget. Meeting called to order with the pledge of allegiance by Walter Rollin. Also present were Jed Lamb, Robert Holmes, Dennis Finkel, Carl Strekely and Sheila Lanning. Fiscal Officer presented the 2021 budget of \$428,610.19 and a budget review document. Hearing no comments, *Motion* by Holmes with a second by Lamb to close the Public Hearing at 6:07 PM. Roll call: 3 yeas.

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Walter Rollin. Also present were Jed Lamb, Robert Holmes, Dennis Finkel, Carl Strekely and Sheila Lanning.

Motion by Lamb with a second by Rollin to approve the minutes of the June 15, 2020 regular scheduled meeting as written. Roll call: 3 yeas. Checks 9159-9186 and payments totaling \$39,140.16 were approved for payment. Financial reports for June were presented, *Motion* by Holmes with a second by Lamb to approve the June Financial reports showing year to date Revenue of \$252,926.44, year to date expenditures of \$160,759.65 and cash balances of \$411,326.27. Roll call: 3 yeas.

Motion by Lamb with a second by Rollin to authorized *Resolution 2020-37* amending 2020 appropriations with a total increase in the budget of \$34,100.00. Roll call: 3 yeas. *Motion* by Lamb with a second by Holmes to authorize *Resolution 2020-38* 2021 proposed budget of \$428,610.19 as presented. Roll call: 3 yeas.

COMMITTEE REPORTS:

WATER BOARD- Meeting coming up, national rural water conference in September cancelled. Holmes: some glitches with the phone system. Lamb: they have been fixed.

LORCO- nothing.

AMBULANCE- Holmes: three meetings coming up, asked if a trailer could be brought in to house the Ambulance personnel. Discussion on plans for a permanent housing for the Ambulance. Originally on a 5 year plan to build. *Consensus* to disapprove of a trailer or mobile home. Lanning: requested # of runs from the Huntington Satellite office.

SHERIFF- 72 calls in Township in June

FIRE- Rollin: meeting last Wednesday, deed will be gotten together in the next week. Requested a letter from the Township stating who is on the Fire Board and length of their term.

OPWC- nothing

SWAC- Lanning: sent invoice to Pittsfield, Wellington and Rochester Townships \$550.00 each for their portion of the Gradall. Need the MOU for the culvert replacement on New London Eastern Road signed. *Motion* by Lamb with a second by Rollin to authorize *Resolution 2020-39* executing the MOU for the culvert replacement on New London Eastern Road to be completed by the Lorain County Engineer. Roll call: 3 yeas. Request for \$8,800.00 grant for Gradall will be sent to Storm Water Advisory Committee when check is processed. Discussion on County using the Township as a lever to get more funding for projects through SWAC. Holmes: it is a culvert and not a bridge for which the Engineer has money. Finkel: Engineer getting money off the top of SWAC that may go against Townships who also applied but no money left. Bob Klaiber and Pete Szwick are doing the grading on the projects.

ZONING BUSINESS/NEWS- Finkel: tried again to talk with Clar Mar, name changed to Twin Lakes. Nothing further on the New London Eastern or Hawley Road or State Route 58 properties. Holmes: Klaiber called about request for stop signs on New London Eastern and Hawley Road. Not enough accidents to make it a four way stop but they can do it if the Township wants. Lamb: that will not solve the issue; need to take two feet off the roadside.

THRIVE & OFFICE ON AGING- Rollin: trying to get food bank August 17th.

CEMETERY- Lanning: forwarded 2021 grant information. Discussion on applying for \$1,000.00 grant, Lamb: put in 40 hours of work for \$1,000.00 opportunity.

ROAD CHIP AND SEAL: Finkel: Melway did a very good job on the chip and seal. *Motion* by Lamb with a second by Holmes to authorize *Resolution 2020-40* payment of \$83,132.00 to Melway for chip and seal work and include a thank you note. Roll call: 3 yeas. Lanning: does Engineer approve job prior to payment, will email Engineer.

ROAD SIGNS- Finkel: no word on the grant for road signs.

EQUIPMENT- Finkel: Roller fixed, would not lift. Lamb: found a backhoe for \$30,000.00. Finkel: interested in less hours on equipment, current backhoe estimated worth \$20,000.00, will look into the backhoe. Finkel: Road grader gauges or sending units are going bad. Gradall paperwork done and will pick up the equipment by the end of the week.

RECYCLE- Lanning: resubmitted the grant request with concrete block quote, need to sign MOU. *Motion* by Lamb with a second by Rollin to authorize *Resolution 2020-41* executing the Solid Waste Management MOU. Roll call: 3 yeas. Can go ahead and get concrete blocks.

TRASH CONSORTIUM- Holmes: talking about having a meeting. **EMPLOYEES-** nothing

OLD BUSINESS:

LAND USE PLAN- on hold until Census data is complete.

NEW BUSINESS:

Salt Vendor for 2021 is Compass at \$49.99 for 75 tons, sent information to Rochester Township. Holmes: presented a New Hire process for review.

PUBLIC PARTICIPATION: Carl Strekely stated the railroad crossing on West Road has been repaired after it was closed 7/6/2020-7/10/2020. The roads all look very good.
