

"Sought through prayer and meditation to improve our conscious contact with God as we understood Him, praying only for knowledge of His will for us and the power to carry that out."

He said: Early in my sobriety, when I was contemplating Step Three, my sponsor had me start to read Step 11 in the Big Book. I read pp.85-88 every day for 90 days. There are 90 hash marks on the bottom of page 85 in my Big Book. It was a start towards a daily practice.

For a while I kept up the practice meditating 20 minutes in the morning, 20 minutes at night. I attended an hour long meditation on Sunday nights and I felt the benefits as I began to get to know my higher power while I walked through Steps 3 - 9.

On page 85 in Step 10 it also talks about the danger of resting on my spiritual laurels, which is what I did as I stopped meditating on a regular basis. And when life happened, as it does, I was once again irritable and discontented. Then someone reminded me at the end of a meeting what I already knew. They asked, "Are you saying your morning meditation and prayers?"

It was just what I needed to hear. And so I started up again, 20 minutes in the morning and 20 minutes in the evening. Sudden things seemed a whole lot easier.

Sobriety is progressive and I co-create sobriety with my higher power when I take the time to pray and meditate. This is the main growth in my spiritual program that I can bring to my 12 step work. Just do it.

In the Doctor's Opinion it refers to the allergy that is the physical reaction to alcohol in an alcoholic, and the obsession of the mind. I have learned in this program that the obsession of the mind in the Alcoholic is the inability to distinguish true from false. An alcoholic who is drunk will always act on emotions rather than intellect. I **kept telling** myself that it was the alcohol that got me drunk when all along I got myself drunk. I kept telling myself that you were to blame instead of looking at why it bothered me so much to coexist with you.

She said: "There is nothing left of me, I'm like a ruby held up to the sunrise. Is it still a stone, or a world made of redness? It has no resistance to sunlight.....the ruby and the sunrise are one...." Rumi

In seventh grade Dad sat down the family and told us he didn't believe in God anymore. He said, "Your mother believes in God, but I don't. Either "belief" is Ok.....I encourage you to think for yourselves." Having been raised quite religiously, I was devastated. My entire foundation for living came into question. That night I prayed to God for a sign. I waited. Nothing. I decided to Fast. As days went by and I got hungrier, my rebellion built. If God existed, he didn't care about me. I gave up; I ate. This has been (by far) my deepest wound, and I lived in absolute darkness for the next 10 years.

At age 21 I encountered God again. A boyfriend overdosed and I found him dead in his bed. I was shocked for many reasons, but the most lasting impression was that Matt didn't look a thing like himself dead. Without his spirit, his "light" was gone. From this point forward, spirit and God became undeniable and my search began again. Connection with a higher power became my SOUL focus and I made meditation a regular part of my life.

But, I still never attempted to pray. The rejection I felt as a little girl had caused me to fear prayer. I never wanted to feel the pain of that wound again and I didn't know how to heal it.

Learning to pray has been a slow process, and I am still learning. The first thing I've found is that I have to practice. I MUST try. I have also discovered that prayer is more about listening then talking.

I try to start each morning with meditation (sitting quietly for a minute or two), to calm my mind, and then (cont. p. 2)



He Said: *(cont.)* **In sobriety I** don't have to let my emotions dictate my actions. Today I ask, "What is the best thing for my sobriety?" Just because I know the right thing to do it doesn't mean that I won't be sad or scared to do it. This is where inventory and meditation come into action on the path of spirituality, *right now*. Month of October in Our History:

October 20, 1928: Beginning on this date, and for the next several years, was the increased frequency of Bill's pledges to stop drinking, as he wrote vows on the flyleaf of Lois's family bible. Experts have found that Bill's promise can be matched by a fear legible in the handwriting itself as it moves down the page. It is at this time that Bill crossed over the invisible line, which every alcoholic crosses, into chronic inebriation. Bill developed a fear of even leaving their home because someone or something would "kill him."

October A.D. 780: Medical records discovered show Italian physicians offered this standard prescription for "alcohol consumption beyond the normal." "Chopped beef fried with many onions."

October 1937: Meetings for Alcoholics only are being held weekly at Bill and Lois's home at 182 Clinton St. in Brooklyn, New York.

October 1941: Fitz Reverend Sam Shoemaker breaks away from the 'Oxford Group' which by this time had changed its name to the 'Moral Re-Armament'.

October 1947: John A.A. was established in Australia. The American actress Lillian Roth came to South Australia to address a public meeting arranged by the Methodist Church to help alcoholic. The very first meeting was held at 'Central Mission" on Franklin St., St. Adelaide, Australia.

October 30th, 1951: 'The Lasker Award' is presented to AA for outstanding contributions to public health.
