MIRMA GRANT AWARD. (Kelly Beets)

Mr. Beets presented Chief Mallory with the Association's Risk Management Grant for \$1912.50. This will pay 75% of Police/City Hall camera security system and four new body cameras. Mr. Beets also presented the Police Department with the 100% online training participation award.

Agent Heather DeHart went over options for employee health insurance and the insurance industry as a whole. Current plan of the city is an excellent plan and city is able to continue with it another year. DeHart thinks current plan will not be available next year. Mallard discussed what Insurance Committee had decided since the premium went up 26%. Committee recommends having employees contribute to their health insurance at \$50 a month. Chief Mallory stated he understands the discussion but health insurance has always been a benefit that was paid by the city. Our city employees are not the highest paid employees and having this benefit has helped compensate them. Paying toward their health insurance will be a pay cut for the employees. Board trying to be as fair as possible to the employees.

Motion by Bowman to have employees start contributing \$50 a month toward their health insurance starting January 1, 2019. Second Mallard.

Hokanson reported caps can be purchased at MFA for about \$5. Issue is getting property owners aware their clean outs are compromised and need attention. Louderbaugh will write letters to property owners to inform them of the issue.

FAIR GROVE SENIOR CENTER INC. REQUEST A STREET LIGHT BE INSTALLED ON S. ORCHARD BLVD.

Terry Smith requested a street light be installed across street from the Senior Center. Consensus of the Board is that public funds cannot be spent in such a manner.

WALKER STREET SEWER EXTENSION AS BUILT PLANS. (Short)

Short reported the city has been lacked in getting as built plans on all sewer extensions. Short has been requesting plans from Wilson Survey on the Walker Lane extension for some time. Plans finally received. We should have received the plans when project was completed several months ago. Wilson Survey sent a bill to the city for the as built plans. These plans should not be at city expense.

DISCUSS CITYWIDE TRASH SERVICE. TWO YEAR NOTICE WILL EXPIRE JANUARY 27, 2019.

Short reported the two year notice will expire January 27, 2019. With changes in board members every year just checking to see how this board feels about moving forward with a franchised trash service. Danderson wants citizens to have a choice. Mallard is for free enterprise. Faherty for free enterprise. Short reported the city has time to change their mind; we have up to a year to make a change after the two year notice.
