ORDINANCE #15-7

AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF LATAH,
WASHINGTON, FOR THE FISCAL YEAR ENDING DECEMBER 2016.

WHEREAS, the mayor of the Town of Latah, Washington completed and placed on file with the city clerk a proposed budget required to meet the expenses of said town for the fiscal year ending December 31, 2016, and notice was published that the council of said city would meet on the 1st day of December, 2015 after the hour of 7:00 p.m., at the council chambers in the town hall of said town for the purpose of making and adopting a budget for said fiscal year and giving taxpayers within the limits of said town an opportunity to be heard upon said budget; and

WHEREAS, the said Town Council did meet at said time and place and did then consider the matter of said proposed budget; and

WHEREAS, the said proposed budget does not exceed the lawful limit of taxation allowed by law to be levied on the property within the Town of Latah for the purposes set forth in said budget, and the estimated expenditures set forth in said budget being all necessary to carry on the government of said town for said year and being sufficient to meet the various needs of said town during said period.

NOW, THEREFORE, the Town Council of the Town of Latah do ordain as follows:

Section 1. The budget for the Town of Latah, Washington, for the year 2016 is hereby adopted at the fund level in its final form and content as set forth in the document entitled, Town of Latah, Final Budget for 2016. Town of Latah budget copies of which are on file in the Office of the Clerk.

Section 3. This ordinance shall be in force and take effect five (5) days after its publication according to law.


