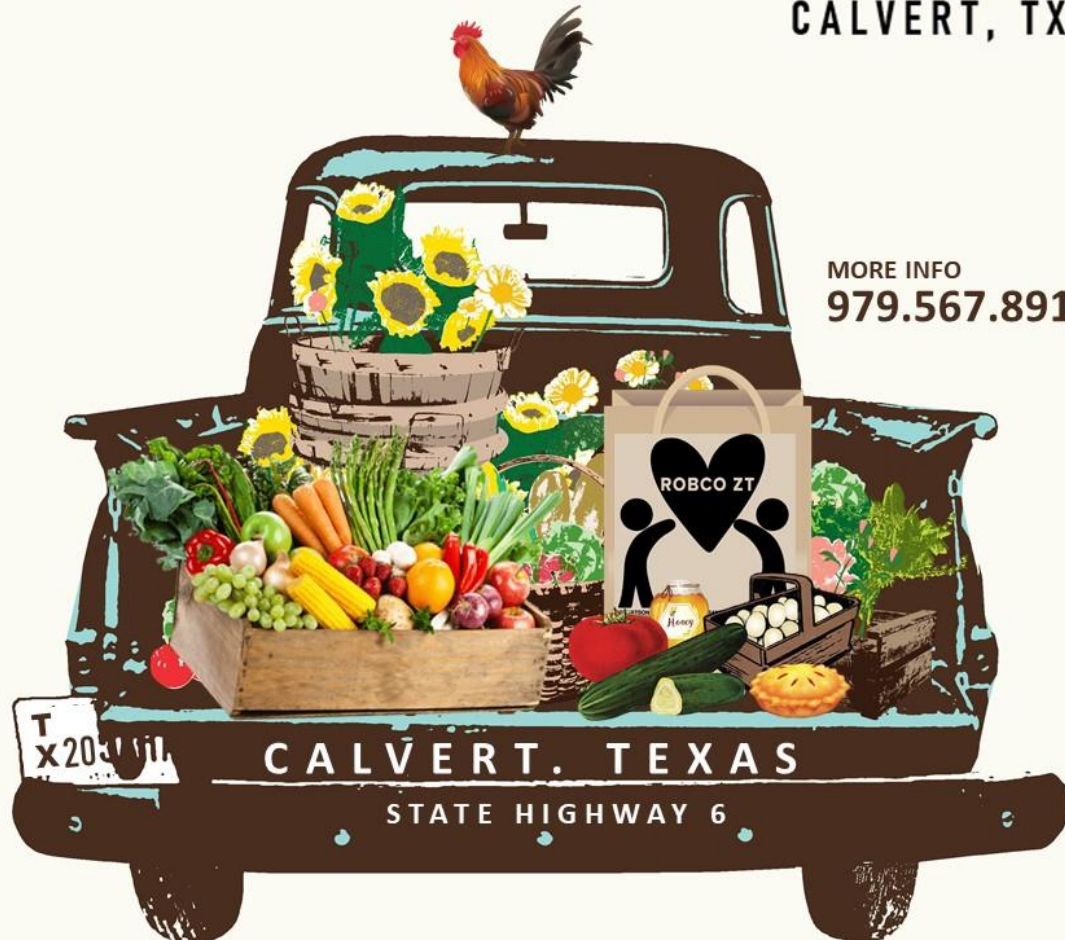

If you do not follow the rules set out by Calvert Main Street Preservation, City of Calvert and Robertson County, the market manager may ask you to leave and you will not be invited to participate in future markets.

**LIABILITY IN CONSIDERATION OF THE ACCEPTANCE OF THE RIGHT TO PARTICIPATE:** Entries, participants and spectators, by execution of this form release and discharge the Calvert Main Street Preservation, City of Calvert, Robertson County and their officers, directors, employees, agents, representatives, and servants and anyone else connected with the management or presentation of the Main Street Farmers Market from any and all known damages, injuries, losses, judgments, and or claims of any causes whatsoever that may be suffered by any and all known entrants to this person or property.

# MAIN STREET FARMERS MARKET

## VENDOR APPLICATION SUMMER 2021– RULES AND GUIDELINES

*Application with signature are required to participate as a vendor at the Main Street Farmers Market.*

1. Main Street Farmers Markets are held every Saturday at 8:00 am until 1 pm (or sell-out) beginning May 8, 2021 through August 2021. At the discretion of the Market Manager, a Saturday market may be cancelled in the event of inclement weather.
2. The Main Street Farmers Market is currently held in the 700 block of Main Street (State Highway 6) in Calvert, TX, in the lot next to the Calvert Historical Foundation Museum at 701 S. Main St and/or 700-702 S. Main (corner of Hanna). Everyone is invited to come and sell their produce and agriculture related products. Each vendor sets their own market prices and is responsible for weighing/measurements, scales, packaging, tent, tables, etc.
3. A 10 ft. by 10 ft. booth space is available for the entire Summer Market with approved application. If you require more space, please indicate on the application and let the Market Manager know. Vendor spaces will be reserved for vendors that participate on a weekly basis. Please inform the market manager in advance if you plan to attend or not. It is your responsibility to communicate with the market manager prior to each Saturday if you will be participating to secure a spot and availability.
4. Items sold must be farm-grown or home-grown **LOCALLY** in Robertson County area or homemade, hand-crafted and agriculture related. We define “LOCAL” as being within a 50-mile radius of Calvert. If your products are Texas-made but outside the 50-mile area, please contact the Market Manager to request an exception for your product. The Market Manager is responsible for approving all items sold at the market.
5. Disrespectful behavior and language will not be tolerated since this market is a family venue.
6. Items must remain in your vendor booth space and not overflow into another vendor’s space. Do not obstruct the customer’s walk way. Clean the area in and around your booth space before you leave for the day. Due to recent COVID-19 situation, use your judgement and follow CDC social distancing guidelines.
7. You are responsible for all licenses and permits required by law to sell your products at a farmers market. This includes a Texas Sales Tax Permit, Food Manufacturing License, Nursery License and Food Handlers Permit when applicable. Your permit(s) and business name must be available and displayed if applicable by law at your booth. For more information about the Texas Cottage Food Law, visit <http://texascottagefoodlaw.com/>. 8. **PARKING:** After you find a booth space and unload your booth items into the space, please move your vehicle to the block behind the lot on Main Street to allow space for market customers and be ready to open by 8:00 am. The Calvert Historical Foundation has generously allowed us to use in front of their lot for the Main Street Farmers Market. Please help us thank them by respecting the museum and its visitors and property. In addition, 700 & 702 S. Main sidewalk will also be available for markets and used at the discretion of the Market Manager. As the Farmers Market grows, our goal is to expand the market throughout the 8 block business district on Main Street.
9. The Main Street Farmers Market is a project of Calvert Main Street Preservation. There are no vendor fees for the summer and your one-time approved application includes all Saturdays through the summer market. We sincerely appreciate your interest and support. *Questions?
