Mr. Yeoman has been rescheduled for July 15th and I am supposed to inspect and let the Judge know the status. This also has been an ongoing issue for years, and it also needs to be rectified.

I received complaint in regards to grass not being maintained at 20 McKay St. and the condition of the house and the front porch area. Notice has been send and I will monitor the location.

I received a complaint about the property at 11763 Bowles Corners Rd., the grass has yet to be cut this year and is over three (3) feet high. Notice has been issued to secure compliance.

I have reached out to the owner of 32 Main St. about the grass not being maintained, he is in Florida and my hands are tied at this point. If the Board wants to have cut buy outside contractor I can do that, but who flips the bill.

I have heard no more information in regards to the Wind project other than what I have been told by Town Supervisor.

6 River St. has removed the unregistered vehicles from his property, he has five drivers in the family and 2 extra registered vehicles for his mail route.

I did receive a call in reference to a swimming pool ladder that gets left in the pool and not locked at any time, I will pay a visit to this location and inform them of the regulations for swimming pools.

I received a permit application for Fire Works from Young Explosives off of Edmond Rd. All insurances and certifications are on file.
