\* Dancers will need to meet me outside the park entrance no later than 1:45 pm. Performance time is 2:00-2:45 (or until we are done dancing). Due to unknown weather conditions, please have your dancer dressed in layers that can be removed. This way they stay warm until it's their time to perform. Dancers are asked to wear any Studio 7 gear if you have and plain black pants (sweatpants, exercise pants, etc) (merchandise orders will be in before the Festival Park performance). If you don't have any merchandise, please wear red/black/yellow or white. Dancers will have free admission into Festival Park; however, everyone going into the park to watch the dancers will have to pay a regular park admission cost. Years ago we had blizzard like conditions at the time we were to perform, the stage was covered in snow, and we had to cancel. If the weather is looking bad again, please keep checking your email if it becomes unsafe to be dancing outside.
