ANYTHING ADDITIONAL WILL BE BILLED ADDITIONALLY ONE THE CLOSING IS COMPLETE AND THE BALANCE OF THAT IS DUE WITHIN 15 DAYS OF THE INVOICE DATE. IF PAYMENT IS NOT RECEIVED WITHIN 15 DAYS OF INVOICE, A \$25.00 LATE FEE WILL BE ASSESSED, AND AS PER OUR CREDIT CARD AGREEMENT THE REQUIRED CREDIT CARD WILL BE CHARGED FOR THE BALANCE AND THE LATE FEE NO EXCEPTIONS. IN THE EVENT THAT COLLECTION PROCEDURES ARE REQUIRED, THE CUSTOMER WILL BE RESPONSIBLE FOR ALL LATE PENALTIES, AND ALL LEGAL AND COLLECTION FEES. WINTERIZATION PAYMENT IS EXPECTED PRIOR TO JOB COMPLETION, AS IT IS THE CLOSE OF OUR SEASON. YOUR CO-OPERATION IN THIS MATTER IS GREATLY APPRECIATED.

YOU WILL BE NOTIFIED BY TELEPHONE IF IN THE UNLIKELY SITUATION YOUR DATE HAS TO BE CHANGED.

OASIS POOL SERVICE IS FULLY INSURED AND IS A MEMBER OF THE ASSOCIATION OF POOL AND SPA PROFESSIONALS. OASIS POOL SERVICE FULLY GUARANTEES THEIR WORK. IF ANY DAMAGE OCCURS TO THE SWIMMING POOL DUE TO OUR IMPROPER WINTERIZATION, THE DAMAGE WILL BE REPAIRED AT NO COST TO YOU THE SWIMMING POOL OWNER. THIS GURANTEE ONLY APPLIES IF THE WINTERIZATION IS DONE BEFORE ANY HEAVY, HARD FREEZES OCCUR. THIS GUARANTEE COVERS THE FILTER SYSTEM, POOL PLUMBING AND POOL PUMP. IT DOES NOT COVER THE DECK, COPING, TILING, PAINT, POOL SHELL, SKIMMERS, OR THE POOL COVER.

NOTICE OF CANCELLATION

You may cancel this transaction, without any penalty or obligation, within three business days from the date of signed contract. If you cancel, any property traded in, any payments made by you under the contract or sale, and any negotiable instrument executed by you will be returned within ten business days following receipt by the seller of your cancellation notice, and any security interest arising out of the transaction will be cancelled.

If you cancel, you must make available to the seller at your residence in substantially as good condition as when received, any goods delivered to you under this contract or sale; or you may, if you wish, comply with the instructions of the seller regarding the return shipment of the goods to the seller's expense and risk.

If you do make the goods available to the seller and the seller does not pick them up within twenty days of the date of your notice of cancellation, you may retain or dispose of the goods without any further obligation. If you fail to make the goods available to the seller, or if you agree to return the goods to the seller and fail to do so, then you remain liable for performance of all obligations under the contract.
