The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

California sales tax will be added to all taxable items. This list does not include prices for certain items that you may ask us to buy for you; such as, but not limited to, outside cemetery or crematory services, flowers, motorcycle escorts for outside processions, and newspaper notices. The charges for these items will be shown on your bill or statement describing the funeral goods and services you selected. We charged you for our service in buying these items.

Due to casket dimensions, persons who are of a size and weight that does not fit within the standards will need to purchase a casket which will accommodate their size. Additional fees may apply for extra preparation time. Additional fees may also be charged at the receiving cemetery.

“Prior to drafting any contract for goods or services, the responsible party or the decedent’s survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.”

A majority of families we serve tend to select funeral arrangements and services in keeping with the options listed. While you are free to arrange services on an itemized basis, the enclosed service plans will simplify the funeral arrangement process. If you ask us to provide additional items, additional charges may apply. Your funeral counselor welcomes your questions.

PROFESSIONAL SERVICES:

BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF: \$1145.00

Our service charge includes consultation with the family, clerical and administrative services, coordinating with the cemetery, crematory, or other third parties responsible for the arrangements made. A percentage of this fee is necessary to cover a proportionate share of our established overhead costs such as licenses, insurance, and indirect taxes (does not include sales tax on items in the merchandise category), maintenance of facilities and equipment, utilities and a host of other costs related to being in business to serve the public. This Cost will also include the cost of attempting to obtain a valid death certificate.

California law requires the physician to sign the medical portion of the death certificate within 15 hours of death. ***We will not be responsible for delays in services or dispositions where a physician has failed to discharge his final duty to the patient and their family.***

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burial and forwarding or receiving remains.

TRANSFER OF REMAINS TO THE FUNERAL HOME: \$495.00

Within a 20 mile radius. Charge \$2.00 per mile after 20 miles.

Added charge for a second removal person (such as response to a residence)..... \$95.00

Stand by time, or case not ready when called (which makes for a second attempt)..... \$197.50

(Per hour, Or any portion thereof)

EMBALMING: \$800.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. If embalming is declined and the final disposition of the deceased is not completed within 24 hours from the time of death, refrigeration is required by law.

This option includes basic professional services of the director and staff, embalming and other preparations, death certificate and permit processing, use of facilities and staff for the funeral ceremony in our chapel, coordination and staff for the graveside service and visitation/viewing (up to three hours), local transfer of the deceased to our care (one attendant included), and necessary auto equipment.

Additional personnel are required for all deaths occurring at a residence or board and care facility. Merchandise, taxes, permits, and fees are not included in our options.

We do not cremate persons over 350 pounds due to equipment limitations.

Additional fees will apply if you opt to have services with the cremation. You may opt for either a memorial service, with or without the cremated remains present, or you may opt to have the casketed remains present.

IMMEDIATE BURIAL (No Service) \$1667.00 to \$8167.00

Our charge for immediate burial (without ceremony) includes basic services of funeral director and staff, transfer of remains to our mortuary, refrigeration, care of remains (not embalming), attempting to obtain the death certificate, file necessary permits, and burial at the convenience of Roosevelt Memorial Park. *For off grounds delivery only to another cemetery, additional fees shall apply.*

The only warranties, expressed or implied, granted in connection with the merchandise sold are the express written warranties, if extended by the manufacturer thereof. No warranties and no warranties of merchantability or fitness for a particular purpose are

extended by the Seller. Manufacturers of merchandise purchased for future needs are subject to change. Warranty information, if any, will be available at the time of need.

Payment Policy:

In order to serve all families fairly and to prevent misunderstanding, RMPA has established a uniform payment policy.

Payment in full is required 48 working hours prior to the furnishing of any merchandise, ceremonies or disposition. Acceptable forms of payment are: cash, money order, cashier's check, Visa/Mastercard. Life Insurance policies MAY be accepted for Roosevelt Mortuary only (Insurance policies are NOT acceptable when only using Roosevelt Memorial Park) under the following conditions:

1. The policy is in force and is assignable
2. The insurance company provides the mortuary with written assurance that they will pay the funeral home and that there are enough funds in the insurance to pay for the contracted arrangements.
3. All beneficiaries of the policy are in agreement and will sign all necessary documents to release funds to the mortuary.
4. That the above be accomplished a minimum of 48 hours prior to the furnishing of any merchandise, ceremonies or disposition.

There will be a \$100.00 processing fee per policy for insurance assignments. Policies under two years old are generally contestable and may not be accepted.

Should a credit balance result from adjustments to the contract, a refund will be issued after the 15th of the month following the month in which services were held to allow time for the processing of any billing adjustments received from outside service providers.

Personal checks, third party checks and credit cards in the name of the decedent will not be accepted.
