## “Drop – and- Go” Form

I understand that only items that meet the high standards of (IWTB) will be accepted for resale. If some of my items are unacceptable for resale, I instruct (IWTB) to either:

\_\_\_\_\_ Return my items to me, which I agree to pick up within 24 hours following the notification that some items are unacceptable. If I fail to pick up my items within 24 hours, I agree that such items will become the property of (IWTB) to dispose of as they see fit, including possible donation to a local charity.

\_\_\_\_\_ I do not wish to have my items returned to me. I forfeit the items to (IWTB) to dispose of at their discretion, including possible donation to local charities.

I further understand that the items accepted for resale become subject to a consignment contract with (IWTB) that begins the day the items are priced and entered into the consignment database. Prices will be set by (IWTB) management at the time of consignment. If accepted items are sold, I will receive 50% of the purchase price for clothing and accessories.

Any items may be subject to sales, clearance and/or price adjustments according to the market of demand at the sole discretion of management. At the end of the season (spring/summer season or fall/winter season or the 90 day contract which ever applies), unsold items for that season will be removed from the sales floor. At that time I instruct (IWTB) to either:

\_\_\_\_\_ Make my items available to me to pickup for a period of one week. If my items are not picked up within one week following notification by (IWTB), I agree that the items will become property of (IWTB) to dispose of as seen fit, including possible donation to local charities.

\_\_\_\_\_ I do not wish to have my unsold items returned. Such items will be forfeited to (IWTB) to dispose of at their discretion, including possible donation to the local charities.

I understand that my account balance (my share of the sales proceeds) will be paid to me upon my request or may apply my account balance as in-store credit towards purchases of store merchandise. I agree to call or email (IWTB) in advance (48 hrs.) for payment of large account balances (to allow time to prepare a check).

I understand that (IWTB) will make a concerted effort to sell my items for me, but (IWTB) makes no guarantee that any of my items will sell during the 90-day contract period or at any particular price.

I hereby warrant that I am the owner of the items that I cosign with (IWTB), and I understand that I will continue to be the owner of such items for the entire consignment period. I agree that (IWTB) shall have no liability for the loss or damage of any items I may leave here due to fire, theft, accident or any other cause.
