Children in the 3 & 4 year old class must be potty trained before they can attend First Baptist Weekday Preschool.

The child must be the appropriate age by September 1 to be enrolled into the appropriate class.

Enrollment is not official until (1) student is accepted into the program, (2) all application and enrollment fees are paid, (3) the Parental Agreement Form is signed, and (4) all necessary forms are on file with Curriculum Based Preschool Program.
