Refreshments and Booths from the different clubs met before the meeting started.

Meeting called to order at 11:12 am by Alestor Linton-Pryor who then had to leave to take part in certification meetings. The meeting was then turned over to acting chair, Shirley Oliver.

Invocation by Reverend Katrina Reeves

Pledge of Allegiance lead by Shirley Oliver

Shirley Oliver thanked all for coming out in the rain.

In memoriam of deaths since the previous year included Naomi Ruth Barber-King, sister-inlaw of Martin Luther King Jr., Dexter King, son of Martin Luther King Jr. and Carolotta Scott.

A hat was passed through the audience for donations. (coffee, orange juice and donates were provided).

Credentials Chair, Patricia Hampton, reported they has 83 delegates, 8 guest and 2 candidates. Quorum was achieved so convention could be conducted.

The Election of County Officers was made by acclimation.

Shirley Oliver explained the history behind why so many of the women at Biden's State of the Union was dressed in white: women who worked for the vote and women's equity routinely wore white.

Bruce Fischer introduced candidates:

- Peter Bember who is running for State Senator in District 33 to replace Lee Rankin gave a 5 minute speech.
- Mal Hyman and Daryl Scott are both running to unseat Russell Fry in District 7. Daryl Scott had to attend another convention, Mal Hyman was ill but his campaign manager gave a 5 minute speech on his behalf.

Officers from 20 precincts and 3 alternatives were present and accepted by acclimation to elect them to the executive committee.

Two Resolutions were read and adopted, the first was regarding hateful speech, cease fire in the Israel-Gaza War, etc. (Presented by Grace Gifford, see attachment at back of

minutes) and the second on securing the voting system in South Carolina (by Roberta K). Motions made on both, seconded and carried.

Election of Delegates were discussed. We send 120 (60 men and 60 women – this was corrected later on 3/19/24 at the HCPD office where it was clarified that NO gender quotas are in place) to the State Convention. Chair Alestor Linton-Pryor has the ability to make guest of other delegates to be made delegates. Motion made that all guests who signed up to go to the State Convention who have registered as delegates to be approved by Alestor. Motion made, seconded, carried.

## Announcements were made

- Bruce Fischer announced Voter Registration event to take place at Freewoods Farm. Call HCDP office or speak with Bruce to sign up for 1 - 2 hour blocks.
- A new "Freedom School" was recently established in SC.
- Each club spoke on their meeting times, dates and upcoming events and speakers.
- Shirley asked previous chairs to stand up to show the diversity in our party.
- It was announced that the State Convention is to be held on May 18, 2024 in Columbia. Venue to be announced later.

Chair Alestor Linton-Pryor spoke about the President's State of the union address and received a standing ovation for her comments. She summarized the President's accomplishments and mentioned that the Myrtle Beach Airport received a \$10 million dollar grant to pay for the new construction currently going on at the Myrtle Beach airport.

Grace Gifford asked people to drop lanyards off at front desk.

**WHEREAS:** Horry County Democratic Party works to build diversity, upholds the principles of equality and human rights and values all life; and
