Fire Chief's Report

In the month of October 2010, Rye Fire responded to 46 calls for service (9 fires and 37 EMS). In comparison with the same time period in 2009, we saw a 40% reduction in call for service for the month and a 7% increase for the year to date.

On October 28, Rye Firefighters assisted Rye Elementary School, the Colorado National Guard, the Federal Bureau of Investigation, and the Drug Enforcement Agency, for the celebration of "Red Ribbon Week." The purpose of Red Ribbon Week is to encourage children to live drug free.

On October 29 through November 2, Daniel Johnson responded to the Dome Fire to assist Boulder County. Daniel Johnson was the Safety Officer for the incident.

On October 29, Colorado Natural Gas completed the gas line to our building in Colorado City.

On November 12, Rye Fire staff members provided refresher CPR and First Aid training to the staff of Rye Telephone Company.

IRS Tax Issue

On November 3, 2010 at the Greenhorn Valley Freedom Forum was made aware of and provided a copy of a Federal Tax Lien that was placed upon the fire district with the internal revenue service. We have been working on a couple issues with the IRS since January 2010 none of which included anything in 2006 or 2008. Specifically working on items from 2007. When given the copy of the lien, spoke with the agent we have been working with, she replied that this should be cleared up by now. Spoke with her about it, she requested some discussion and information about 2008 and 2009 941 which she believed we owed \$1,800, she then provided us a certificate of release of tax lien. The tax lien was \$51,000, it covers 6721 which is the code that covers giving the Social Security Administration in filing W2s at end of year, and in 2006 we did file and were able to prove this occurred. The 941 for the 2nd quarter 2008. On the lien it is showing balance of \$54,294.93 the actual amount was the \$1,800.00, we have paid the \$1,800.00 and have cleared the tax lien and was provided a copy of the release.

Mr. Cook has input on the lien including questions and concerns.

Chief Daniels said the lien was signed on the 20th of May.

Chief Daniels stated we had no record of the lien prior its recording, and thanked Mr. Cook and the freedom forum for the information so we were able to get it resolved.
