### **OLD BUSINESS:**

1. All signs have been received from the ODOT grant. We will ask for an extension to have these installed.
2. Joos property on Becks Knob Road has water flowing through their property when it rains. Will look at extending the culvert.

### **NEW BUSINESS:**


1. We have tree estimates from three vendors. Mid Ohio won the bid. Trustee Wolfe motioned to accept the Mid Ohio Tree quote for \$4,400. Trustee Ellinger second the motion. Roll call vote Ellinger – Yes, Wolfe – Yes, Claypool – Yes. Motion approved.
2. Trustee Ellinger attended the health department meeting. They discussed setting out mosquito traps for West Nile Virus. So far none has been reported. They are applying for accreditation.
3. It has been brought to the Trustee's attention that the property next to the firehouse is available to purchase. Trustee Claypool asked the property owner to submit a cost to review.

Trustee Ellinger moved to pay the warrants for the month seconded by Trustee Claypool. Roll call vote Ellinger – Yes, Wolfe – Yes, Claypool – Yes. Motion approved.




